## <u>AMENDMENTS TO HOUSE BILL 371</u> (Third Reading File Bill)

### AMENDMENT NO. 1

On page 1, in line 2, strike "<u>Authorization for Counties to Exempt</u>"; in line 3, strike "<u>Mortgages</u>" and substitute "<u>Mortgage Exemption – Threshold Amount</u>"; and strike beginning with "<u>authorizing</u>" in line 5 through "<u>transactions</u>" in line 7 and substitute "<u>altering the threshold amount for certain indemnity mortgage transactions</u> that are exempt from the recordation tax".

#### AMENDMENT NO. 2

On page 2, in line 16, strike "\$3,000,000" and substitute "<u>\$12,500,000</u>"; in the same line, after the semicolon insert "<u>OR</u>"; strike in their entirety lines 17 through 22, inclusive; and in line 23, strike "<u>4.</u>" and substitute "<u>3.</u>".

On page 2 and 3, strike in their entirety the lines beginning with line 32 on page 2 through line 26 on page 3, inclusive, and substitute:

"ON OR BEFORE JULY 1, 2025, AND EACH JULY 1 THEREAFTER, THE COLLECTOR OR THE CLERK OF THE CIRCUIT COURT FOR THE COUNTY, WHICHEVER IS DESIGNATED TO COLLECT RECORDATION TAX FOR THE COUNTY, SHALL SUBMIT A REPORT, IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE, TO THE SENATE BUDGET AND TAXATION COMMITTEE AND THE HOUSE WAYS AND MEANS COMMITTEE THAT INCLUDES, FOR THE IMMEDIATELY PRECEDING FISCAL YEAR:

(1) THE TOTAL NUMBER OF INDEMNITY MORTGAGES RECORDED THAT WERE EXEMPT FROM RECORDATION TAX UNDER § 12–105(F)(7)(III)2 OF THIS SUBTITLE; HB0371/333921/01 Budget and Taxation Committee Amendments to HB 371 Page 2 of 2

# (2) THE AMOUNT OF DEBT SECURED BY EACH INDEMNITY MORTGAGE THAT WAS EXEMPT FROM RECORDATION TAX UNDER § 12– 105(F)(7)(III)2 OF THIS SUBTITLE; AND

## (3) THE AMOUNT OF RECORDATION TAX REVENUE FORGONE DUE TO THE INDEMNITY MORTGAGE EXEMPTION FROM RECORDATION TAX UNDER § 12–105(F)(7)(III)2 OF THIS SUBTITLE.".
