On page 1, in line 3, after "of" insert "<u>repealing the authority of the Secretary of Transportation to designate a transit-oriented development</u>;"; in line 11, strike ", (l), (m), and (o)"; strike in their entirety lines 14 through 18, inclusive; in line 21, after "Section" insert "<u>7-101(l) and</u>"; and after line 24, insert:

"BY repealing and reenacting, with amendments,

<u>Article – Transportation</u> <u>Section 7–101(l) through (p) and 7–102(a)</u> <u>Annotated Code of Maryland</u> (2020 Replacement Volume and 2022 Supplement)".

AMENDMENT NO. 2

On page 2, after line 17, insert:

"(L) (1) "TRANSIT CORRIDOR" MEANS A GEOGRAPHICALLY BOUND SET OF TWO OR MORE CONTIGUOUS SUBWAY, LIGHT RAIL, BUS RAPID TRANSIT, OR BUS TRANSIT STATIONS.

On page 3, in line 1, strike "Secretary, after considering a recommendation of the"; in line 4, after "area" insert "<u>APPLYING FOR DESIGNATION</u>"; after line 4, insert:

"[(n)] (O) (1) "Transit service" means the transportation of persons and their packages and baggage and of newspapers, express, and mail in regular route, special, or charter service by means of transit facilities between points within the District.

- (2) <u>"Transit service" does not include any:</u>
 - (i) Vanpool operation; or
 - (ii) Railroad service.";

in line 5, strike "(o)" and substitute "(P)"; after line 9, insert:

"[(p)] (Q) "Transit vehicle" means a mobile device used in rendering transit service.";

in line 26, after "INVESTMENT" insert "<u>, INCLUDING THE COMPLETE STREETS</u> <u>PROGRAM ESTABLISHED UNDER TITLE 8, SUBTITLE 9 OF THIS ARTICLE</u>"; strike beginning with "FEDERAL" in line 27 down through "GRANTS" in line 28 and substitute "<u>ELIGIBLE FEDERAL FUNDING</u>"; and after line 31, insert:
