AMENDMENT NO. 2

AMENDMENT NO. 3

On page 6, after line 32, insert:

"<u>SECTION 2. AND BE IT FURTHER ENACTED</u>, That, on or before December 1, 2024, the Maryland Health Benefit Exchange, in consultation with the Maryland Insurance Administration, shall:

- (1) <u>conduct a study of:</u>
 - (i) available federal and State subsidies;

(ii) the State's § 1332 waiver and whether it should be amended to include young adults or otherwise to maximize federal pass-through funds and impact the largest number of individuals so as to reduce the State's uninsured rate; and

(iii) <u>the number of individuals who signed up for health insurance</u> <u>through the Exchange because of the young adult subsidy; and</u>

(2) report to the Senate Finance Committee and the House Health and Government Operations Committee, in accordance with § 2-1257 of the State Government Article, on its findings and recommendations.";
