AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Watson" and substitute "Watson, Pena-Melnyk, Cullison, Alston, Bagnall, Bhandari, Chisholm, Guzzone, Hill, Hutchinson, S. Johnson, Kaiser, Kerr, Kipke, Lopez, Martinez, M. Morgan, Reilly, Taveras, White, and Woods"; in line 2, strike "Overdoses –"; after line 2, insert:

"(The Josh Siems Act)";

in line 3, strike "the emergency department of"; in the same line, strike "conduct a rapid" and substitute "<u>include testing for fentanyl as part of a</u>"; strike beginning with "test" in line 4 down through "provider" in line 5 and substitute "<u>screening</u>"; in line 6, after "for" insert "<u>hospital</u>"; and in the same line, strike "with a known or suspected overdose".

AMENDMENT NO. 2

On page 1, in line 16, strike "(B)" and substitute "(C)"; strike beginning with "AN" in line 16 down through "INDIVIDUAL" in line 20 and substitute "IF AN INDIVIDUAL IS TREATED AT A HOSPITAL AND THE HOSPITAL CONDUCTS A URINE DRUG SCREENING TO ASSIST IN DIAGNOSING THE INDIVIDUAL'S CONDITION, THE HOSPITAL SHALL INCLUDE TESTING FOR FENTANYL IN THE INDIVIDUAL'S URINE DRUG SCREENING.

(B) IF THE URINE DRUG SCREENING CONDUCTED IN ACCORDANCE WITH SUBSECTION (A) OF THIS SECTION DETECTS FENTANYL, THE HOSPITAL SHALL REPORT THE TEST RESULTS, WHICH SHALL BE DEIDENTIFIED, TO THE

in line 21, strike "(B)" and substitute "(C)"; and in line 22, strike "THE EQUIPMENT TO CONDUCT A RAPID URINE DRUG TEST" and substitute "CHEMICAL ANALYZER EQUIPMENT".

On page 2, in line 1, strike "(C)" and substitute "(D)"; and in line 2, after "INDIVIDUAL" insert "WHO IS IN NEED OF MEDICAL ASSISTANCE AFTER INGESTING OR USING ALCOHOL OR DRUGS, OR TO AN INDIVIDUAL".
