AMENDMENT NO. 1

On page 1, in line 4, after "centers" insert "that serve only dependent children of military personnel and are"; and in line 6, after "State;" insert "authorizing certain entities and agents to assume certain responsibilities regarding the children served by child care providers that are exempted from certain requirements under this Act;".

AMENDMENT NO. 2

On page 2, in line 1, before "THIS" insert "(A)"; in line 2, strike "IS"; in line 3, strike "LOCATED" and substitute "SERVES ONLY DEPENDENT CHILDREN OF MILITARY PERSONNEL; AND

(2) (I) <u>IS LOCATED</u>";

in line 4, strike "(2) CERTIFIED" and substitute "(II) IS CERTIFIED"; in the same line, strike "FAMILY CHILD CARE PROVIDER" and substitute "CHILD DEVELOPMENT PROGRAM"; after line 5, insert:

in line 26, strike "(2) CERTIFIED" and substitute "2. IS CERTIFIED"; in the same line, strike "FAMILY CHILD CARE PROVIDER" and substitute "CHILD DEVELOPMENT PROGRAM"; and after line 27, insert:
