AMENDMENT NO. 1

On page 1, in the sponsor line, strike “Delegate Shetty” and substitute “Delegates Shetty, Pena–Melnyk, Cullison, Alston, Bagnall, Bhandari, Chisholm, Guzzone, Hill, Hutchinson, S. Johnson, Kaiser, Kerr, Kipke, R. Lewis, Lopez, Martinez, M. Morgan, Reilly, Rosenberg, Szeliga, Taveras, White, and Woods”.

AMENDMENT NO. 2

On page 2, in line 3, strike “AND”; in line 4, after “(4)” insert “THE CHAIR OF THE STATE ADVISORY COUNCIL ON HEREDITARY AND CONGENITAL DISORDERS, OR THE CHAIR’S DESIGNEE;

(5) ONE REPRESENTATIVE OF THE OFFICE OF MINORITY HEALTH AND HEALTH DISPARITIES, DESIGNATED BY THE DIRECTOR OF THE OFFICE;

(6) ONE REPRESENTATIVE OF THE MARYLAND MEDICAL ASSISTANCE PROGRAM, DESIGNATED BY THE SECRETARY;

(7) ONE REPRESENTATIVE OF THE MARYLAND INSURANCE ADMINISTRATION, DESIGNATED BY THE MARYLAND INSURANCE COMMISSIONER; AND

(8);

strike in their entirety lines 7 through 12, inclusive; and in lines 13, 15, 18, 20, 23, 25, and 27, strike “(V)”, “(VI)”, “(VII)”, “(VIII)”, “(IX)”, “(X)”, and “(XI)”, respectively, and substitute “(II)”, “(III)”, “(IV)”, “(V)”, “(VI)”, “(VII)”, and “(VIII)”, respectively.

On page 3, in lines 1, 3, 5, and 7, strike “(XII)”, “(XIII)”, “(XIV)”, and “(XV)”, respectively, and substitute “(IX)”, “(X)”, “(XI)”, and “(XII)”, respectively; in line 6, strike “AND”; and in line 8, after “RESEARCH” insert “; AND”

(XIII) ONE REPRESENTATIVE OF AN ORGANIZATION THAT PROVIDES CARE MANAGEMENT FOR INDIVIDUALS ENROLLED IN THE STATE’S RARE AND EXPENSIVE CASE MANAGEMENT PROGRAM”.

On page 5, strike in their entirety lines 1 and 2; in lines 3, 8, 11, 13, and 16, strike “(6)”, “(7)”, “(8)”, “(9)”, and “(10)”, respectively, and substitute “(5)”, “(6)”, “(7)”, “(8)”, and “(9)”, respectively; and in line 4, after “PATIENTS” insert “, INCLUDING PATIENTS WITH PRIVATE HEALTH INSURANCE COVERAGE AND PATIENTS”; and in lines 10 and 21, in each instance, strike “WEBSITE” and substitute “WEBPAGE”.

On page 6, in line 17, strike “four” and substitute “seven”; in the same line, after “members” insert “, including one member appointed under § 13–4802(a)(8)(vii) of the Health – General Article.”; in the same line, strike “2025;” and substitute “2028; and”; in line 18, strike “six” and substitute “seven”; in the same line, after “members” insert “, including one member appointed under § 13–4802(a)(8)(vii) of the Health – General Article.”; in the same line, strike “2026; and” and substitute “2030.”; and strike line 19 in its entirety.
