AMENDMENTS TO SENATE BILL 483  
(Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, strike “establishing the Private Well Safety Program in” and substitute “requiring”; strike beginning with “manage” in line 4 down through “remediation” in line 7 and substitute “adopt regulations on or before a certain date to identify additional standards for water quality testing”; in line 8, after “Environment” insert “, subject to certain funding and in consultation with the Department of Information Technology.”; in line 9, strike the first comma and substitute “and”; strike beginning with the second comma in line 9 down through “portal” in line 12; in line 15, after “manner;” insert “requiring the Department of the Environment to share certain information consistently with the Maryland Department of Health and local health departments and to encourage the Maryland Department of Health and local health departments to share certain information to the online portal;” and strike in their entirety lines 21 through 23, inclusive, and substitute “Section 9-4A-01 through 9-4A-03”.

On page 2, strike line 4 in its entirety and substitute “Section 9-4A-01”.

AMENDMENT NO. 2

On page 2, strike line 15 in its entirety.

On pages 2 and 3, strike in their entirety the lines beginning with line 19 on page 2 through line 5 on page 3, inclusive.

On page 3, in lines 6, 12, and 20, strike “**(G)**”, “**(H)**”, and “**(K)**”, respectively, and substitute “**(B)**”, “**(C)**”, and “**(D)**”, respectively; strike in their entirety lines 14 through 19, inclusive; and strike line 29 in its entirety.

On page 4, strike in their entirety lines 1 and 2; and in line 3, strike “~~9-4A-04~~” and substitute “9-4A-02”.

On pages 4 through 8, strike in their entirety the lines beginning with line 4 on page 4 through line 18 on page 8, inclusive.

On page 8, in line 19, strike “(G)” and substitute “(A)”; in the same line, strike “THE” and substitute “ON OR BEFORE DECEMBER 31, 2026, THE”; in line 21, strike the comma and substitute “.

(B)”;

in line 22, strike “INCLUDING REQUIRING” and substitute “REGULATIONS ADOPTED IN ACCORDANCE WITH THIS SECTION MAY REQUIRE”; and in line 27, strike “ALL” and substitute “OTHER”.

On pages 8 through 10, strike in their entirety the lines beginning with line 29 on page 8 through line 14 on page 10, inclusive.

On page 10, in line 15, strike “~~9-4A-13.~~” and substitute “9-4A-03.”; in line 16, strike “THE” and substitute “SUBJECT TO THE AVAILABILITY OF FUNDING FOR THE PLANNING AND IMPLEMENTATION OF AN ONLINE PORTAL AND, IN CONSULTATION WITH THE DEPARTMENT OF INFORMATION TECHNOLOGY, THE”; in line 26, strike “AN ONGOING BASIS,” and substitute “IMPLEMENTATION OF THE ONLINE PORTAL UNDER THIS SECTION:”

(1)”;

in the same line, strike “A” and substitute “A”; and in line 29, strike the period and substitute “; AND”.

On page 11, in line 1, strike “(C)” and substitute “(2)”; in the same line, strike “ON A QUARTERLY BASIS, A” and substitute “A”; in line 6, strike “(D)” and substitute “(C)”; strike in their entirety lines 13 through 15, inclusive; and in line 16, strike “9-4A-16.” and substitute “9-4A-04.”.

On page 13, strike beginning with the colon in line 20 down through “A” in line 21 and substitute “A”; in lines 22 and 24, strike “1.” and “2.”, respectively, and substitute “(I)” and “(II)”, respectively; and strike beginning with the semicolon in line 25 down through “POSTED” in line 29.

On page 15, in line 1, after “That” insert “the Department of the Environment shall”; in lines 2 and 5, strike “(a)” and “(b)”, respectively, and substitute “(1)” and “(2)”, respectively; in line 2, strike “The Department of the Environment shall”; in line 4, strike the period and substitute a semicolon; in line 5, strike “On” and substitute “on”; in the same line, strike “the Department of the Environment shall”; in line 6, after “recommendations” insert “for long-term funding options under item (1) of this section”; and in line 7, after “Assembly” insert “; and”

- (3) assist in identifying a funding source for a private well grant fund”.
