On page 3, in line 12, after "<u>1</u>." insert "<u>A</u>."; strike beginning with the semicolon in line 12 down through "<u>2</u>." in line 13 and substitute "<u>AND</u>"; strike beginning with the colon in line 14 down through "<u>A</u>." in line 15; in line 17, strike "<u>A</u>" and substitute "<u>IS AT</u> <u>LEAST 22 YEARS OLD AND WORKS FOR REMUNERATION OR AS A VOLUNTEER FOR</u> <u>A</u>"; in line 18, strike "<u>3</u>." and substitute "<u>2</u>."; in line 24, after "<u>MEANS</u>" insert "<u>:</u>

(II) ANY UNIT OF LOCAL, STATE, OR FEDERAL GOVERNMENT".

"<u>1.</u> <u>IS PARTICIPATING IN A PROGRAM FOR WHICH THE</u> <u>PERSON IN A POSITION OF AUTHORITY WORKS; AND</u>

2. IS AT LEAST 6 YEARS YOUNGER THAN THE PERSON IN A POSITION OF AUTHORITY";

and strike beginning with "<u>A</u>" in line 28 down through the second "<u>CRIME</u>" in line 32 and substitute:

"(1) UNLESS SPECIFICALLY CHARGED BY THE STATE, A VIOLATION OF THIS SECTION MAY NOT BE CONSIDERED A LESSER INCLUDED CRIME OF ANY OTHER CRIME.

(2) <u>A SENTENCE IMPOSED UNDER THIS SECTION MAY BE IMPOSED</u> <u>SEPARATE FROM AND CONSECUTIVE TO OR CONCURRENT WITH A SENTENCE FOR</u> <u>ANY CRIME BASED ON THE ACT ESTABLISHING THE VIOLATION OF THIS SECTION</u>".
