AMENDMENTS TO SENATE BILL 766
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 4, after “on” insert “owner-occupied”; in line 5, strike “authorizing the Mayor of Baltimore City to cancel the annual tax sale;”; in line 6, after “divert” insert “owner-occupied”; in line 9, after “any” insert “owner-occupied”; in line 10, after “of” insert “owner-occupied”; in line 11, after “establishing” insert “certain”; and in line 17, after “for” insert “Owner-Occupied”.

AMENDMENT NO. 2

On page 2, strike beginning with “ANY” in line 8 down through “FROM” in line 10; in line 10, after “AS” insert “THE”; in line 11, after “ROLL” insert “MAY ENROLL”; strike beginning with “ANY” in line 17 down through “(2)” in line 19; in line 20, after “PROGRAM;” insert “AND”; in line 21, strike “(3)” and substitute “(2)”; and strike beginning with the semicolon in line 21 down through “SECTION” in line 23.

On page 2 in line 7, and on page 3 in line 29, in each instance, after “ANY” insert “OWNER-OCCUPIED”.

On page 3, strike beginning with “(I)” in line 13 down through “(II)” in line 15; in line 16, after “DIVERT” insert “OWNER-OCCUPIED”; in lines 19, 21, and 23, strike “1.”, “2.”, and “3.”, respectively, and substitute “(I)”, “(II)”, and “(III)”, respectively; in line 22, after “ARTICLE;” insert “AND”; and strike beginning with the semicolon in line 24 down through “PROGRAM” in line 26.

On page 4, in line 1, after “FOR” insert “OWNER-OCCUPIED”; strike in their entirety lines 4 through 21, inclusive; in lines 22 and 25, strike “(B)” and “(C)”, respectively, and substitute “(A)” and “(B)”, respectively; in line 23, after “OF” insert

“OWNER-OCCUPIED”; and in line 25, strike “A” and substitute **“AN OWNER-OCCUPIED”**.

On pages 4 and 5, strike beginning with “AT” in line 27 on page 4 down through **(2)** in line 2 on page 5.

On page 5, in line 5, strike **(3)** and substitute **(2)**; in lines 8 and 14, strike **(D)** and **(E)**, respectively, and substitute **(C)** and **(D)**, respectively; in line 9, after “WITHHOLDING” insert **“OWNER-OCCUPIED”**; in line 15, after “SHALL” insert **“FOLLOW THE PROCEDURES ESTABLISHED UNDER”**; and strike beginning with “FILE” in line 16 down through “WITH” in line 19 and substitute **“PART V OF THIS SUBTITLE FOR THE FORECLOSURE AND SALE OF VACANT OR NUISANCE PROPERTY DESCRIBED UNDER § 14-874(A) OF THIS SUBTITLE; AND**

On pages 5 and 6, strike in their entirety the lines beginning with line 20 on page 5 through line 31 on page 6.

On page 7, in line 1, strike **(2)** and substitute:

“(E) ON THE ENTRY OF A JUDGMENT IN ACCORDANCE WITH THE PROCEDURES ESTABLISHED UNDER § 14-876 OF THIS SUBTITLE FOR THE SALE OF VACANT OR NUISANCE PROPERTY, THE COURT SHALL”;

and in lines 2, 2, 7, 10, 16, 22, 25, and 27, strike **(M)**, **(L)**, **(N)**, **(O)**, **(P)**, **(Q)**, **(R)**, and **(S)**, respectively, and substitute **(F)**, **(E)**, **(G)**, **(H)**, **(I)**, **(J)**, **(K)**, and **(L)**, respectively.
