AMENDMENTS TO SENATE BILL 796
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 4, after “Sundays” insert “, subject to certain time restrictions.”; in line 5, after “County” insert “, subject to certain time restrictions”; and in line 11, strike “10–410(a)(1)(i)” and substitute “10–410(a)(1)”.

AMENDMENT NO. 2

On page 2, in line 18, after “**12.**” insert “**SUBJECT TO SUBPARAGRAPH (V) OF THIS PARAGRAPH,**”; in the same line, after “**COUNTY**” insert “, **FROM 30 MINUTES BEFORE SUNRISE UNTIL 10:30 A.M**”; and after line 18, insert:

“(ii) The time restrictions under subparagraph (i)10 of this paragraph do not apply:

1. On each Sunday of the deer firearms season; and
2. On the last three Sundays in October and the first two Sundays in November of the deer bow hunting season.

“(iii) The time restrictions under subparagraph (i)2, 3, 5, and 8 of this paragraph do not apply:

1. On each Sunday during the deer firearms season;
2. On the last three Sundays in October and the first two Sundays in November during the deer bow hunting season; and
3. On each Sunday of the spring turkey hunting season.

“(iv) The time restrictions under subparagraph (i)6 of this paragraph do not apply:

1. On each Sunday of the deer hunting seasons from the first Sunday in October through the second Sunday in January, inclusive; and

2. On each Sunday of the spring turkey hunting season.

(V) THE TIME RESTRICTIONS UNDER SUBPARAGRAPH (I)12 OF THIS PARAGRAPH DO NOT APPLY:

1. ON THE FIRST SUNDAY OF THE DEER FIREARMS SEASON; AND

2. ON THE LAST THREE SUNDAYS IN OCTOBER AND THE FIRST TWO SUNDAYS IN NOVEMBER OF THE DEER BOW HUNTING SEASON.”.

On page 3, in lines 18 and 19, strike “**WICOMICO COUNTY;**

7.”;

in lines 21 and 23, in each instance, strike the brackets; in the same lines, strike “**8.”** and “**9.”**, respectively; in line 22, strike “and”; in line 25, after “a.m.” insert “**;AND**

9. SUBJECT TO SUBPARAGRAPH (III) OF THIS PARAGRAPH, WICOMICO COUNTY, FROM 30 MINUTES BEFORE SUNRISE UNTIL 10:30 A.M.”;

in line 26, strike the brackets; and in the same line, strike “**(I)9”**.”

On page 4, after line 2, insert:

“(III) THE TIME RESTRICTIONS UNDER SUBPARAGRAPH (I)9 OF THIS PARAGRAPH DO NOT APPLY:
