AMENDMENTS TO HOUSE BILL 357

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “**Delegate Kipke**” and substitute “**Delegates Kipke, Alston, Bagnall, Bhandari, Chisholm, Cullison, Guzzone, Hill, Hutchinson, S. Johnson, Kaiser, Kerr, R. Lewis, Lopez, Martinez, M. Morgan, Pena–Melnik, Reilly, Rosenberg, Szeliga, Taveras, White, and Woods**”; in line 2, strike “**Definitions**” and substitute “**Definition**”; in the same line, strike “**Carrier, ERISA, and**”; in the same line, after “**Purchaser**” insert “**and Alteration of Application of Law**”; strike beginning with “repealing” in line 3 down through “definition” in line 4 and substitute “**altering the definition**”; in line 4, strike “applying”; strike beginning with “certain” in line 5 down through “(ERISA)” in line 8 and substitute “**exclude certain nonprofit health maintenance organizations**”; in line 8, strike “a”; in the same line, strike “provision” and substitute “**provisions**”; in the same line, strike “restricts” and substitute “**restrict the**”; in line 14, strike “15–1606,”; and in line 15, strike “15–1628(a), 15–1628.3,”; in the same line, after “15–1629,” insert “**and**”; in the same line, strike “, and 15–1633.1”; and strike in their entirety lines 18 through 22, inclusive.

AMENDMENT NO. 2

On page 2, in lines 6 and 16, in each instance, strike the bracket; in line 19, strike the brackets; in the same line, strike “**(E)**”; in lines 24, 25, and 26, in each instance, strike the brackets; and in lines 25 and 26, strike “**(F)**” and “**(G)**”, respectively.

On page 3, in lines 11, 13, 15, 17, 19, 21, and 26, in each instance, strike the brackets; and in the same lines, strike “**(H)**”, “**(I)**”, “**(J)**”, “**(K)**”, “**(L)**”, “**(M)**”, and “**(N)**”, respectively.

On page 4, in lines 20, 22, and 26, in each instance, strike the brackets; and in the same lines, strike “(O)”, “(P)”, and “(Q)”, respectively.

On page 5, in lines 11, 14, 25, and 27, in each instance, strike the brackets; in the same lines, strike “(R)”, “(S)”, “(T)”, and “(U)”, respectively; and strike line 29 in its entirety.

On page 6, strike in their entirety lines 1 and 2; in lines 15 and 19, in each instance, strike the brackets; and in lines 16 and 19, in each instance, strike “**15-1633**”.

On pages 7 and 8, strike in their entirety the lines beginning with line 24 on page 7 through line 24 on page 8, inclusive.

On page 13, strike in their entirety lines 10 through 20, inclusive.
