AMENDMENTS TO HOUSE BILL 98
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike “**Declarations and**”; strike beginning with “exempting” in line 3 down through the semicolon in line 4; in line 6, after “policy;” insert “requiring owners of detached units to carry homeowners insurance on the entirety of the unit;”; and in line 10, strike “11–103(a)(4) and”.

AMENDMENT NO. 2

Strike in their entirety the lines beginning with line 16 on page 1 through line 17 on page 2.

AMENDMENT NO. 3

On page 4, in line 1, after “(e)” insert “**(1)**”; and after line 2, insert:

“(2) AN OWNER OF A RESIDENTIAL, DETACHED UNIT SHALL CARRY HOMEOWNERS INSURANCE COVERAGE ON THE ENTIRETY OF THE UNIT.”

AMENDMENT NO. 4

On page 2, in line 24, after the bracket insert “**AGAINST RISKS OF DIRECT PHYSICAL LOSS COMMONLY INSURED AGAINST**”; and strike beginning with the comma in line 26 down through “**AGAINST**” in line 27.

On page 3, strike beginning with “For” in line 13 down through the comma in line 16 and substitute “**SUBJECT TO THE APPLICABLE COVERAGE SPECIFIED UNDER SUBSECTION (A)(1) OF THIS SECTION,**”; in line 17, strike “his” and substitute “**THE UNIT OWNER’S**”; in line 18, after “owners” insert “**FOR PROPERTY AND CASUALTY LOSSES TO THE COMMON ELEMENTS AND THE UNITS, EXCLUSIVE OF**

IMPROVEMENTS AND BETTERMENTS INSTALLED IN THE UNITS BY UNIT OWNERS OTHER THAN THE DEVELOPER"; in line 27, strike "Any loss **FOR ATTACHED OR MULTIFAMILY DWELLING UNITS**" and substitute "**SUBJECT TO THE APPLICABLE COVERAGE SPECIFIED UNDER SUBSECTION (A)(1) OF THIS SECTION, ANY LOSS**"; in line 28, strike "under subsection (a)(1) of this section"; in line 34, after "**(3)**" insert "**(I)**";

in line 35, after "and" insert "**, FOR CONDOMINIUMS WITH ATTACHED OR MULTIFAMILY UNITS THAT MUST MAINTAIN A PROPERTY INSURANCE POLICY ON THE UNITS, THE DAMAGED**"; in line 36, strike ", and unit" and substitute "**.**

(II) UNIT";

in line 37, strike "there" and substitute "**:**

1. THERE";

in the same line, after "and" insert "**, FOR CONDOMINIUMS WITH ATTACHED OR MULTIFAMILY UNITS THAT MUST MAINTAIN A PROPERTY INSURANCE POLICY ON THE UNITS, THE**"; and in line 38, strike ", or the" and substitute "**; OR**

2. THE".

On page 4, in line 9, strike "**(A)**" and substitute "**(A)(1)**".
