"(II) FOR WHICH THE GRANT-MAKING ENTITY HAS RECEIVED, AND FAILED TO SUBMIT TO THE COMPTROLLER WITHIN 30 DAYS OF ITS RECEIPT, A PROPER INVOICE.";

strike in their entirety lines 17 and 18; in line 19, strike "**31ST**" and substitute "<u>**38TH**</u>"; and strike beginning with the colon in line 19 down through "LATER," in line 22.

On page 5, strike beginning with ", **BUT**" in line 1 down through "**RECEIPT**," in line 2; strike beginning with ", **THE**" in line 5 down through "**DETERMINATION**" in line 7 and substitute "<u>AND SUBMITS THE INVOICE TO THE COMPTROLLER, THE</u> <u>COMPTROLLER SHALL MAKE PAYMENT WITHIN 5 BUSINESS DAYS</u>"; and after line 24, insert:

"(6) THIS SECTION DOES NOT CREATE LIABILITY ON THE COMPTROLLER FOR INTEREST ACCRUED ON A LATE PAYMENT.".
