11 12	WHEREAS, The amount of glass used in new building construction is increasing dramatically in Maryland and worldwide; and
13 14 15	WHEREAS, The increase in the use of glass in buildings threatens to undo energy conservation efforts, cost the State money, and contribute to climate change and biodiversity loss; and
16 17 18	WHEREAS, Adopting building standards to protect birds will reduce energy consumption, making State buildings more sustainable and saving taxpayers money; now, therefore,
19 20	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

23	(a) In this title the following words have the meanings indicated.
24	(b) "Department" means the Department of General Services.
25	(c) "Secretary" means the Secretary of General Services.

27 28	(A) (1) IN THIS SECTION, THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
29 30	(2) "ACQUIRED" DOES NOT INCLUDE A BUILDING LEASED BY THE STATE.
31	(3) "STATE BUILDING" MEANS:

- 1 (1) A BUILDING ACQUIRED THROUGH ANY MEANS BY THE 2 STATE FOR USE BY A STATE AGENCY OR DEPARTMENT;
- 3 (2) (II) A BUILDING CONSTRUCTED OR RENOVATED BY OR FOR THE 4 STATE FOR OCCUPANCY BY A STATE AGENCY OR DEPARTMENT; OR
- 5 (3) (III) A BUILDING ACQUIRED, CONSTRUCTED, OR RENOVATED 6 FOR WHICH MORE THAN 50% OF THE MONEY FOR THE ACQUISITION, 7 CONSTRUCTION, OR RENOVATION CAME FROM STATE FUNDS.
- 8 (B) THIS SECTION DOES NOT APPLY TO:
- 9 (1) A PUBLIC WORK CONTRACT OF LESS THAN \$500,000;
- 10 (2) A PUBLIC WORK CONTRACT FOR WHICH 50% OR LESS OF THE 11 FUNDS USED FOR THE PROJECT ARE STATE FUNDS; OR
- 12 (3) A PROJECT FOR WHICH FUNDING IS PROVIDED IN THE CAPITAL BUDGET AS A GRANT TO A NONPROFIT ORGANIZATION; OR
- 14 (4) A PUBLIC SCHOOL CONSTRUCTION PROJECT.
- 15 (C) (1) EXCEPT AS PROVIDED IN PARAGRAPH (4) OF THIS SUBSECTION,
  16 THE DEPARTMENT SHALL ESTABLISH STANDARDS FOR STATE BUILDINGS TO
  17 CONSERVE ENERGY AND MINIMIZE ADVERSE IMPACTS ON BIRDS THAT ARE
  18 CONSISTENT WITH THE U.S. GREEN BUILDING COUNCIL'S LEED
  19 INNOVATION CREDIT 55 FOR REDUCING BIRD COLLISIONS AND THE AMERICAN
  20 BIRD CONSERVANCY BIRD-FRIENDLY DESIGN RECOMMENDATIONS.
- 21 (2) THE DEPARTMENT SHALL UPDATE THE STANDARDS DEVELOPED 22 UNDER PARAGRAPH (1) OF THIS SUBSECTION EVERY 5 YEARS.
- 23 (3) THE STANDARDS DEVELOPED UNDER THIS SUBSECTION SHALL SPECIFY THAT, EXCEPT WHERE FULL OPERATION OF BUILDING LIGHTING IS DOCUMENTED AS NECESSARY, INCLUDING FOR PUBLIC SAFETY OR OTHER PURPOSES, INTERIOR AND EXTERIOR LIGHTING SHALL BE APPROPRIATELY SHIELDED AND MINIMIZED FROM MIDNIGHT TO DAWN EACH DAY:
- 28 (I) FROM MARCH 1 THROUGH MAY 31, BOTH INCLUSIVE; AND
- 29 (II) FROM AUGUST 1 THROUGH OCTOBER 31, BOTH INCLUSIVE.

- 1 (4) THE STANDARDS ESTABLISHED UNDER PARAGRAPH (1) OF THIS
  2 SUBSECTION MAY NOT INCLUDE A REQUIREMENT FOR BIRD COLLISION
  2 MONITORING
- 3 MONITORING.
- 4 (5) THE DEPARTMENT SHALL CONSIDER THE PHYSICAL HEALTH AND 5 MENTAL HEALTH OF BUILDING OCCUPANTS WHEN DEVELOPING OR UPDATING 6 STANDARDS UNDER PARAGRAPH (1) OF THIS SUBSECTION.
- 7 (D) EACH STATE BUILDING CONSTRUCTED, SUBSTANTIALLY ALTERED, OR
  8 ACQUIRED BY THE STATE SHALL MEET, TO THE EXTENT PRACTICABLE AND WITHIN
  9 BUDGETARY CONSTRAINTS AS DETERMINED BY THE DEPARTMENT, THE STANDARDS
  10 ESTABLISHED UNDER SUBSECTION (C) OF THIS SECTION.
- 11 (E) THE DEPARTMENT SHALL REDUCE THE LIGHTING OF EXISTING STATE
  12 BUILDINGS, TO THE EXTENT PRACTICABLE AND WITHIN BUDGETARY CONSTRAINTS
  13 AS DETERMINED BY THE DEPARTMENT:
- 14 (1) IN ACCORDANCE WITH SUBSECTION (C)(3) OF THIS SECTION; AND
- 15 (2) BY USING AUTOMATIC CONTROL TECHNOLOGIES, WHICH MAY 16 INCLUDE TIMERS, PHOTOSENSORS, INFRARED DETECTORS, AND MOTION 17 DETECTORS.
- 18 (F) (1) THE SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, THE
  19 MARYLAND GREEN BUILDING COUNCIL SHALL INCLUDE THE STANDARDS
  20 ESTABLISHED UNDER THIS SECTION IN ANY REQUIREMENTS THAT THE COUNCIL
  21 ESTABLISHES FOR PARTICIPATION IN A HIGHER PERFORMANCE BUILDING
  22 PROGRAM IN THE STATE THE MARYLAND HIGH PERFORMANCE GREEN BUILDING
  23 PROGRAM.
- 24 (2) STANDARDS INCLUDED IN THE MARYLAND HIGH PERFORMANCE
  25 GREEN BUILDING PROGRAM UNDER THIS SUBSECTION SHALL APPLY ONLY TO
  26 STATE BUILDINGS AS DEFINED IN THIS SECTION.
- 27 (G) THE SECRETARY SHALL ADOPT REGULATIONS TO CARRY OUT THE 28 PROVISIONS OF THIS SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 30 October 1, 2023.
