CHAPTER _____

1 AN ACT concerning

2 **Hate Crimes – Civil Remedy**

3 FOR the purpose of providing that a person who is the victim of an act that would constitute
4 a violation of certain hate crime laws may bring a civil action against a certain
5 person; and generally relating to the right to file a civil action for a hate crime.

6 BY adding to

7 Article – Criminal Law

9 Annotated Code of Maryland

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Criminal Law**

14 **10–309.**

15 **(A) A PERSON WHO IS THE VICTIM OF AN ACT THAT WOULD CONSTITUTE A**
16 **VIOLATION OF THIS SUBTITLE MAY BRING A CIVIL ACTION AGAINST THE PERSON OR**
17 **PERSONS WHO COMMITTED THE ACT IN A COURT OF COMPETENT JURISDICTION.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.

Underlining indicates amendments to bill.

~~Strike out~~ indicates matter stricken from the bill by amendment or deleted from the law by amendment.



1 **(B) THE COURT MAY:**

2 **(1) ISSUE AN INJUNCTION TO PREVENT OR RESTRAIN AN ACT THAT**
3 **WOULD CONSTITUTE A VIOLATION OF THIS SUBTITLE; AND**

4 **(2) AWARD DAMAGES IN ACCORDANCE WITH SUBSECTION (C) OF THIS**
5 **SECTION.**

6 **(C) (1) DAMAGES AWARDED BY A COURT UNDER THIS SECTION MAY**
7 **INCLUDE:**

8 **(I) ECONOMIC DAMAGES AND ANY OTHER PECUNIARY LOSS**
9 **SUSTAINED BY THE PLAINTIFF THAT WAS PROXIMATELY CAUSED BY THE VIOLATION**
10 **OF THIS SUBTITLE; AND**

11 **(II) NONECONOMIC DAMAGES, INCLUDING:**

12 1. **PAIN AND SUFFERING;**

13 2. **SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION,**
14 **EMOTIONAL DISTRESS;**

15 3. **SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION,**
16 **MENTAL ANGUISH;**

17 4. **LOSS OF ENJOYMENT;**

18 5. **LOSS OF COMPANIONSHIP, SERVICES, AND**
19 **CONSORTIUM; AND**

20 6. **OTHER NONPECUNIARY LOSS SUSTAINED BY THE**
21 **PLAINTIFF THAT WAS PROXIMATELY CAUSED BY THE ACT THAT WOULD CONSTITUTE**
22 **A VIOLATION OF THIS SUBTITLE.**

23 **(2) THE COURT MAY ALSO AWARD REASONABLE ATTORNEY'S FEES**
24 **AND COURT COSTS TO A PREVAILING PLAINTIFF.**

25 **(3) NONECONOMIC DAMAGES UNDER PARAGRAPH (1)(II)2 AND 3 OF**
26 **THIS SUBSECTION MAY NOT INCLUDE EMOTIONAL DISTRESS OR MENTAL ANGUISH**
27 **CAUSED SOLELY BY THE NEED TO REPLACE OR REPAIR PERSONAL OR REAL**
28 **PROPERTY.**

29 **(D) DAMAGES AWARDED BY A COURT UNDER SUBSECTION (C)(1) OF THIS**

1 SECTION MAY BE EQUAL TO THREE TIMES THE AMOUNT OF ACTUAL DAMAGES.

2 (E) THIS SECTION DOES NOT AFFECT ANY LEGAL OR EQUITABLE RIGHT OR
3 REMEDY OTHERWISE PROVIDED BY LAW.

4 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to
5 apply only prospectively and may not be applied or interpreted to have any effect on or
6 application to any cause of action arising before the effective date of this Act.

7 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2023.
