3 4	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
5	Article – Economic Development

7 8	(a) (1) (i) There is a Maryland Nonprofit Development Center Program Fund in the Department.
9 10	(ii) 1. Within the Fund, there is a Nonprofit, Interest–Free, Micro Bridge Loan (NIMBL) Account.
11	2. The Account consists of:
12 13	A. money received under \S 9–1A–27 of the State Government Article; and
14 15	B. any other money appropriated, transferred by budget amendment, or repaid to the Account.

29 30	(b) (1) The purpose of the Fund is to provide grant money and bridge loans to support the operations of the Program consistent with this subtitle.

- 4 **(C) (1)** FOR FISCAL YEAR 2024, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$1,000,000 TO THE FUND TO BE USED 5 FOR LOANS UNDER THE NIMBL ACCOUNT. 6
- 7 **(2)** IF \$1,000,000 IS NOT INCLUDED IN THE ANNUAL BUDGET BILL FOR FISCAL YEAR 2024, THEN THE GOVERNOR SHALL INCLUDE IN THE ANNUAL 8 BUDGET BILL FOR FISCAL YEAR 2025 AN APPROPRIATION OF \$1,000,000 TO BE USED 9 FOR LOANS UNDER THE NIMBL ACCOUNT. 10
