2 Condominiums – Declarations and Mandatory Insurance Coverage – Alterations

- FOR the purpose of exempting certain condominium units from a requirement to include
 certain information in a declaration; altering the types of elements and units for
 which a council of unit owners is required to maintain certain property insurance
 and altering certain requirements for the property insurance policy; requiring
 owners of detached units to carry homeowners insurance on the entirety of the unit;
 and generally relating to mandatory insurance coverage for condominiums.

- 14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
