19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20 That the Laws of Maryland read as follows:

21 **Article – Courts and Judicial Proceedings**

22 3–801.

23 (aa) “Sexual molestation or exploitation” includes:

24 (1) Allowing or encouraging a child to engage in:

25 (i) Obscene photography, films, poses, or similar activity;

26 (ii) Pornographic photography, films, poses, or similar activity; or

27 (iii) Prostitution;

28 (2) Incest;

29 (3) Rape;

30 (4) Sexual offense in any degree; and

31 (5) [Unnatural or perverted sexual practices] **ANY OTHER SEXUAL**
32 **CONDUCT THAT IS A CRIME.**

2 [3–322.

3 (a) A person may not:

4 (1) take the sexual organ of another or of an animal in the person’s mouth;

5 (2) place the person’s sexual organ in the mouth of another or of an animal;

6 or

7 (3) commit another unnatural or perverted sexual practice with another or
8 with an animal.9 (b) A person who violates this section is guilty of a misdemeanor and on conviction
10 is subject to imprisonment not exceeding 10 years or a fine not exceeding \$1,000 or both.

11 (c) A person who violates this section is subject to § 5–106(b) of the Courts Article.

12 (d) An indictment for a violation of this section:

13 (1) is sufficient if it states that the defendant committed an unnatural and
14 perverted sexual practice with a person or animal as applicable; but

15 (2) need not state the particular:

16 (i) unnatural or perverted sexual practice with which the defendant
17 is charged; or18 (ii) manner in which the defendant committed the unnatural or
19 perverted sexual practice.]

20 3–602.

21 (a) (4) (i) “Sexual abuse” means an act that involves sexual molestation or
22 exploitation of a minor, whether physical injuries are sustained or not.

23 (ii) “Sexual abuse” includes:

24 1. incest;

25 2. rape;

26 3. sexual offense in any degree; and

27 4. [unnatural or perverted sexual practices] **ANY OTHER**

1 **SEXUAL CONDUCT THAT IS A CRIME.**

2 3–604.

3 (a) (9) (i) “Sexual abuse” means an act that involves sexual molestation or
4 exploitation of a vulnerable adult.

5 (ii) “Sexual abuse” includes:

6 1. incest;

7 2. rape;

8 3. sexual offense in any degree; and

9 4. [unnatural or perverted sexual practices] **ANY OTHER**
10 **SEXUAL CONDUCT THAT IS A CRIME.**

11 3–809.

12 (a) (1) In this section the following words have the meanings indicated.

13 (5) “Sexual activity” means:

14 (i) sexual intercourse, including genital–genital, oral–genital,
15 anal–genital, or oral–anal[, whether between persons of the same or opposite sex];16 [(ii) an unnatural or perverted sexual practice under § 3–322 of this
17 title;18 (iii)] **(II)** masturbation; or19 [(iv)] **(III)** sadomasochistic abuse.20 (c) A person may not knowingly distribute a visual representation of another
21 identifiable person that displays the other person with his or her intimate parts exposed or
22 while engaged in an act of sexual activity:23 (1) with the intent to harm, harass, intimidate, threaten, or coerce the
24 other person;25 (2) (i) under circumstances in which the person knew that the other
26 person did not consent to the distribution; or27 (ii) with reckless disregard as to whether the person consented to the
28 distribution; and

1 (3) under circumstances in which the other person had a reasonable
2 expectation that the image would remain private.

5 (a) (1) In this section the following words have the meanings indicated.

6 (2) “Qualifying offense” means:

7 (i) unnatural or perverted sexual practice under § 3–322 of the
8 Criminal Law Article, **AS THAT OFFENSE EXISTED BEFORE OCTOBER 1, 2023;**

9 (b) A person convicted of a qualifying offense may file a motion to vacate the
10 judgment if the person’s participation in the offense was a direct result of being a victim of
11 human trafficking.

12 10–105.

13 (a) A person who has been charged with the commission of a crime, including a
14 violation of the Transportation Article for which a term of imprisonment may be imposed,
15 or who has been charged with a civil offense or infraction, except a juvenile offense, may
16 file a petition listing relevant facts for expungement of a police record, court record, or other
17 record maintained by the State or a political subdivision of the State if:

18 (11) except as provided in subsection (a–1) of this section, the person was
19 convicted of a crime and the act on which the conviction was based is no longer a crime;

20 (a–1) An expungement may not be obtained under subsection (a)(11) of this section
21 for a conviction for sodomy as that offense existed before October 1, 2020, **OR A VIOLATION**
22 **OF § 3–322 OF THE CRIMINAL LAW ARTICLE AS THAT OFFENSE EXISTED BEFORE**
23 **OCTOBER 1, 2023,** where the offense was committed:

24 (1) without consent;

25 (2) with a minor under the age of 16;

26 (3) with anyone the individual could not marry under § 2–202 of the Family
27 Law Article;

28 (4) with a mentally incapacitated individual, as defined in § 3–301 of the
29 Criminal Law Article;

30 (5) with a physically helpless individual, as defined in § 3–301 of the
31 Criminal Law Article; or

1 (6) with a substantially cognitively impaired individual, as defined in §
2 3–301 of the Criminal Law Article.

3 11–701.

4 (q) “Tier III sex offender” means a person who has been convicted of:

5 (1) conspiring to commit, attempting to commit, or committing a violation
6 of:

7 (v) the common law offense of sodomy, as that offense existed before
8 October 1, 2020, or § 3–322 of the Criminal Law Article, **AS THAT OFFENSE EXISTED**
9 **BEFORE OCTOBER 1, 2023**, if the offense was committed with force or threat of force; or
10 11–1007.

11 (a) (6) (i) “Sexual abuse” means any act that involves sexual molestation
12 or exploitation of a child whether or not the sexual molestation or exploitation of the child
13 is by a parent or other individual who has permanent or temporary care, custody, or
14 responsibility for supervision of a child, or by any household or family member.

15 (ii) “Sexual abuse” includes[:

16 1.] incest, rape, or sexual offense in any degree[: and

17 2. unnatural or perverted sexual practices].

26 (3) rape;
