Maryland Electricians Act – Revisions

- 3 FOR the purpose of altering the entity that must administer or approve an apprenticeship program for electricians; substituting the term "uninsured" for the term "inactive" in 4 5 certain provisions of law relating to liability insurance requirements for certain 6 electricians; prohibiting a certain electrician from contracting to provide electrical 7 services unless the electrical work is covered by certain liability insurance; specifying 8 who is authorized and required to purchase certain insurance; requiring the State 9 Board of Electricians to specify on each license whether the license holder meets the 10 insurance requirements of certain provisions of this Act; and generally relating to 11 electricians and liability insurance requirements.





 24 TO COVER ELECTRICAL SERVICES THAT A MASTER ELECTRICIAN PROVIDES OUTSIDE

- 26 (D) **(1)** LICENSED APPRENTICE ELECTRICIAN OR LICENSED 27 JOURNEYPERSON ELECTRICIAN IN THE EMPLOY OF A LICENSED MASTER ELECTRICIAN NEED NOT OBTAIN SEPARATE INSURANCE WHILE PROVIDING OR 2829 ASSISTING IN PROVIDING ELECTRICAL SERVICES UNDER THE CONTROL AND 30 SUPERVISION OF THE LICENSED MASTER ELECTRICIAN.
- 31 (2) SUBJECT TO THE RESTRICTIONS OF § 6–311 OF THIS TITLE 32 REGARDING UNINSURED STATUS, UNINSURED LICENSEES WHO HAVE HAD THEIR

5 6 7	(2) The State Board may not issue a State license to an applicant to whom the insurance requirements of this section would apply unless the applicant submits proof of the insurance.
8 9 10	[(d)] (F) Unless an applicant meets the insurance requirements of this section, the State Board may not renew a State license of the applicant to whom the insurance requirements of this section would apply.
$\frac{1}{2}$	[(e)] (G) If the insurance required under this section is canceled, the insurer shall notify the State Board within 10 days after the date of cancellation.
13 14 15 16 17	[(f)] (H) If a local jurisdiction requires [an applicant for a local license] A MASTER ELECTRICIAN OR OTHER PERSON WHO ENGAGES IN THE BUSINESS OF PROVIDING ELECTRICAL SERVICES to execute a bond to the local jurisdiction, the applicant may satisfy the bond requirement by submitting proof of the insurance required under this section.
18	(I) THE STATE BOARD SHALL SPECIFY ON EACH LICENSE WHETHER THE LICENSE HOLDER MEETS THE INSURANCE REQUIREMENTS OF THIS SECTION.

AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three—fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
