A BILL ENTITLED

1 AN ACT concerning

2 **Department of Agriculture – Urban Agriculture Grant Fund**

3 FOR the purpose of altering the purpose and contents of and the requirements and
4 qualifications under the Urban Agriculture Grant Fund; and generally relating to
5 the Urban Agriculture Grant Fund.

6 BY repealing and reenacting, without amendments,

21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
22 That the Laws of Maryland read as follows:

23 **Article – Agriculture**

24 2–2001.

1 (a) In this subtitle the following words have the meanings indicated.

2 (E) “QUALIFIED APPLICANT” MEANS AN AGRICULTURAL PRODUCER, A
3 NONPROFIT ORGANIZATION, OR AN INSTITUTION OF HIGHER EDUCATION THAT
4 MEETS THE QUALIFICATIONS ESTABLISHED IN § 2–2004 OF THIS SUBTITLE.

5 [(e)] (F) “Urban agricultural producer” means any person that annually sells, or
6 normally would have sold, \$1,000 or more of farm products in [Baltimore City] AN URBAN
7 AREA.

8 (G) “URBAN AREA” MEANS AN AREA OF THE STATE THAT IS DELINEATED AS
9 AN URBAN AREA BY THE U.S. CENSUS BUREAU.

10 2–2002.

11 (a) There is an Urban Agriculture Grant Program in the Department.

12 (b) The purpose of the Program is to increase the viability of urban farming and
13 improve access to urban-grown foods.

14 2–2003.

15 (a) There is an Urban Agriculture Grant Fund.

16 (b) The purpose of the Fund is to provide grants to [nonprofit organizations in
17 Baltimore City] QUALIFIED APPLICANTS to implement the Program.

18 (c) The Secretary shall administer the Fund.

19 (d) (1) The Fund is a special, nonlapsing fund that is not subject to § 7–302 of
20 the State Finance and Procurement Article.

21 (2) The State Treasurer shall hold the Fund separately, and the
22 Comptroller shall account for the Fund.

23 (e) The Fund consists of:

24 (1) Money appropriated to the Fund under subsection (g) of this section;
25 and

26 (2) Any other money from any other source accepted for the benefit of the
27 Fund.

28 (f) In accordance with this subsection, the Fund shall be used to provide grants
29 to [nonprofit organizations that:

1 (1) Meet the qualifications established in § 2–2004 of this subtitle; and

2 (2) Distribute the grant money to urban agricultural producers in
3 accordance with this subtitle] **QUALIFIED APPLICANTS.**

4 (g) [The] **FOR EACH OF FISCAL YEARS 2025, 2026, 2027, 2028, AND 2029,**
5 **THE** Governor [may] **SHALL** include in the annual budget bill an appropriation of
6 **\$250,000** to the Fund.

7 (h) (1) The Department shall adopt regulations, subject to the availability of
8 money in the Fund, to provide grants under the Fund.

9 (2) The regulations shall:

10 (i) Establish a Review Board to implement:

11 1. A competitive grant application process that prioritizes
12 applications that [will accomplish the goals of the Urban Agriculture section of the 2019
13 Baltimore Sustainability Plan and historically] **BENEFIT SOCIALLY** disadvantaged urban
14 farmers;

15 2. A system to fairly:

16 A. Evaluate each grant application; and

17 B. Award grants from money available in the Fund; and

18 3. A grant agreement to be used by the Review Board and
19 grant recipients;

20 (ii) Require the Review Board to include [members representing]:

21 1. The [Baltimore Office of Sustainability] **SECRETARY, OR**
22 **THE SECRETARY'S DESIGNEE;**

23 2. [The Baltimore Development Corporation] **ONE**
24 **REPRESENTATIVE OF THE MARYLAND AGRICULTURAL AND RESOURCE-BASED**
25 **INDUSTRY DEVELOPMENT CORPORATION (MARBIDCO), DESIGNATED BY THE**
26 **EXECUTIVE DIRECTOR OF MARBIDCO; [and]**

27 3. [The Department of Planning] **ONE REPRESENTATIVE**
28 **OF THE NATIONAL ASSOCIATION FOR THE ADVANCEMENT OF COLORED PEOPLE**
29 **(NAACP), DESIGNATED BY THE MARYLAND STATE CONFERENCE OF NAACP;**

30 4. **TWO MEMBERS WHO PROVIDE DIRECT EDUCATION**

1 AND TRAINING TO URBAN FARMERS THROUGH A NONPROFIT ORGANIZATION OR AN
2 INSTITUTION OF HIGHER EDUCATION;

3 5. AT LEAST FIVE MEMBERS WITH SUBSTANTIAL
4 EXPERIENCE WORKING IN URBAN AGRICULTURE OR WITH SOCIALLY
5 DISADVANTAGED FARMERS WHO RESIDE IN ANNE ARUNDEL COUNTY, BALTIMORE
6 CITY, MONTGOMERY COUNTY, OR PRINCE GEORGE'S COUNTY; AND

7 6. A STAFF MEMBER OF THE BALTIMORE CITY
8 DEPARTMENT OF PLANNING APPOINTED BY THE DIRECTOR OF THE DEPARTMENT
9 OF PLANNING;

10 (iii) 1. Require that [more than 75% of the Review Board be
11 composed of staff representing an agency of Baltimore City] **TWO MEMBERS OF THE**
12 **REVIEW BOARD BE MEMBERS REPRESENTING A LOW-INCOME CENSUS TRACT, AS**
13 **DEFINED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT;** and

14 2. Require the remainder of the Review Board members to be
15 appointed by the Department, based on the member's ability to help achieve the purpose of
16 the Program under § 2-2002(b) of this subtitle;

17 (iv) [Require grant recipients] **FOR NONPROFIT ORGANIZATIONS**
18 **THAT RECEIVE A GRANT FOR THE PURPOSE OF DISTRIBUTING GRANT MONEY TO**
19 **URBAN AGRICULTURAL PRODUCERS, REQUIRE THE NONPROFIT ORGANIZATION** to
20 distribute at least [70%] **85%** of the amount of the grant to urban agricultural producers
21 to:

22 1. Secure real property:

23 **A. THAT HAS THE NECESSARY INFRASTRUCTURE IN**
24 **PLACE TO GROW FOOD;**

25 **B. FOR WHICH THE GRANTEE WILL BE THE STEWARD OF**
26 **THE REAL PROPERTY; AND**

27 **C. FOR WHICH NOT MORE THAN 20% OF THE GRANT**
28 **MONEY WILL BE USED TO SECURE THE REAL PROPERTY;**

29 2. Maintain safe, environmentally sustainable, and socially
30 responsible practices; and

31 3. [Support] **MAKE CAPITAL IMPROVEMENTS TO**
32 **SUPPORT** viable urban agriculture enterprises;

33 (v) Require that grant applications demonstrate a measurable

1 impact on improving local food access or other community benefits;

2 (vi) **[Require] FOR NONPROFIT ORGANIZATIONS THAT RECEIVE**
3 **A GRANT FOR THE PURPOSE OF DISTRIBUTING GRANT MONEY TO URBAN**
4 **AGRICULTURAL PRODUCERS, REQUIRE** at least **[70%] 85%** of the amount of each grant
5 to be distributed to **[minority-owned or operated]** urban agricultural producers **LOCATED**
6 **IN LOW-INCOME CENSUS TRACTS OR DESIGNATED FOOD DESERTS, OF WHICH AT**
7 **LEAST 25% OF THE GRANT MONEY SHALL BE DISTRIBUTED TO URBAN**
8 **AGRICULTURAL PRODUCERS IN BALTIMORE CITY;** and

9 (vii) Prohibit grant recipients from using more than **[30%] 15%** of the
10 amount of the grant for operating expenses.

11 (3) In adopting regulations in accordance with this subsection, the
12 Department shall seek and prioritize input from urban agriculture farms and farmer
13 advocates.

14 (i) On or before October 15 each year, beginning in 2023 and each year thereafter,
15 the Department shall submit a report to the Governor and, in accordance with § 2-1257 of
16 the State Government Article, the Senate Budget and Taxation Committee and the House
17 Appropriations Committee on the effectiveness of the funding provided under this section.

18 2-2004.

19 (a) A nonprofit organization **OR AN INSTITUTION OF HIGHER EDUCATION** is
20 qualified to receive a grant in accordance with this subtitle if the Department determines
21 **[that the nonprofit organization]:**

22 (1) **[Is] WITH RESPECT TO A NONPROFIT ORGANIZATION, THAT THE**
23 **NONPROFIT ORGANIZATION IS** incorporated or maintains its principal place of business
24 in **[Baltimore City] AN URBAN AREA; [and]**

25 (2) **[Works] THAT THE ENTITY WORKS** to increase the viability of urban
26 farming and improve access to urban-grown foods; **AND**

27 (3) **THAT THE ENTITY WILL PROVIDE DIRECT TRAINING AND**
28 **ONGOING TECHNICAL ASSISTANCE, IN ACCORDANCE WITH A PROGRAM THAT IS**
29 **CERTIFIED BY THE U.S. DEPARTMENT OF AGRICULTURE OR THE DEPARTMENT, TO**
30 **URBAN AGRICULTURAL PRODUCERS THAT RECEIVE A GRANT UNDER THIS**
31 **SUBTITLE.**

32 (B) **AN URBAN AGRICULTURAL PRODUCER IS QUALIFIED TO RECEIVE A**
33 **GRANT IN ACCORDANCE WITH THIS SUBTITLE IF THE DEPARTMENT DETERMINES**
34 **THAT THE URBAN AGRICULTURAL PRODUCER WILL COMPLETE A NEW FARMING**
35 **TRAINING OR CONTINUING EDUCATION PROGRAM.**

1 **[(b)] (C)** Within 90 days after the end of a grant cycle, a qualified nonprofit
2 organization that received a grant in accordance with this subtitle shall submit a report to
3 the Department that includes the following information:

4 (1) The names and locations of urban agricultural producers that received
5 funds under the Program;

6 (2) The dollar amount of funds awarded to each urban agricultural
7 producer; and

8 (3) The impact of the Program on increasing the viability of urban farming
9 and improving access to urban-grown foods.

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
11 October 1, 2023.
