1 2 3 4	(a) Subject to the hearing provisions of § 14–405 of this title, a disciplinary panel on the affirmative vote of a majority of a quorum of the disciplinary panel, may deny a license to any applicant, reprimand any licensee, place any licensee on probation, or suspend or revoke a license, if the applicant or licensee:
5 6	(28) Violates an order of the Board or a disciplinary panel, including any condition of probation; [or]
7 8	(29) Fails to complete a criminal history records check under $\S 14-308.1$ of this title; OR
9 10	(30) Performs dry needling without the approval of the Board issued under § $14-5D-11.4$ of this subtitle.
