2 Massage Therapy – Definition, *Registration*, and Reimbursement

3 FOR the purpose of altering the definition of "massage therapy"; altering the date after 4 which the option to be registered by the State Board of Massage Therapy Examiners to practice massage therapy in a setting that is not a health care setting will no longer $\mathbf{5}$ be available; repealing a provision of law that provides that certain provisions of law 6 7 do not require a nonprofit health insurance plan, an insurer, a health maintenance 8 organization, or a person acting as a third party administrator to reimburse a 9 licensed massage therapist or registered massage practitioner for any services rendered; and generally relating to the regulation of massage therapists and 10 11 massage practitioners.
