A BILL ENTITLED

1 AN ACT concerning

2 **Public Schools – Standardized Behavioral Health Questionnaire for Students –**
3 **Development and Implementation**

4 FOR the purpose of requiring the Maryland Consortium on Coordinated Community
5 Supports to develop, in consultation with certain stakeholders, guidelines for
6 developing a standardized behavioral health questionnaire to identify students with
7 behavioral health services needs; requiring each behavioral health services
8 coordinator to develop and implement a standardized behavioral health
9 questionnaire based on the guidelines developed by the Consortium; requiring that
10 the questionnaire be given to the parent or guardian of each student when the
11 student enrolls for school and with a certain frequency thereafter; and generally
12 relating to the development of a standardized behavioral health questionnaire for
13 public school students.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
8 That Section(s) 7–447.1(l) through (s) of Article – Education of the Annotated Code of
9 Maryland be renumbered to be Section(s) 7–447.1(m) through (t), respectively.

10 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
11 as follows:

12 **Article – Education**

13 7–447.

14 (b) Each local school system shall appoint a behavioral health services
15 coordinator.

16 (c) **(1)** In addition to the requirements under Subtitle 15 of this title, each
17 behavioral health services coordinator shall:

18 **[(1)] (I)** Coordinate existing behavioral health services and referral
19 procedures for behavioral health services within the local school system, including through
20 a coordinated community supports partnership;

21 **[(2)] (II)** Working in collaboration with the local health department, the
22 local department of social services, and other local entities that provide behavioral health
23 services, including a community supports partnership, ensure that a student who is
24 referred for behavioral health services obtains the necessary services in a timely manner;

25 **[(3)] (III)** Maximize external funding for behavioral health and
26 wraparound services;

27 **[(4)] (IV)** Have at a minimum a master’s degree and behavioral health
28 training experience in schools;

29 **[(5)] (V)** Provide the required behavioral health training under § 6–122 of
30 this article; and

31 **[(6)] (VI)** Develop and implement a standardized **[screening]**
32 **QUESTIONNAIRE** to identify students with behavioral health services needs using an

1 evidence-based measurement approach **BASED ON THE GUIDELINES ESTABLISHED**
2 **UNDER § 7-447.1 OF THIS SUBTITLE.**

3 **(2) THE STANDARDIZED QUESTIONNAIRE REQUIRED UNDER**
4 **PARAGRAPH (1)(VI) OF THIS SUBSECTION SHALL BE GIVEN TO THE PARENT OR**
5 **GUARDIAN OF EACH STUDENT WHEN THE STUDENT ENROLLS FOR SCHOOL AND**
6 **EVERY YEAR THEREAFTER WHILE THE STUDENT IS ENROLLED IN THE LOCAL**
7 **SCHOOL SYSTEM.**

9 (a) (1) In this section the following words have the meanings indicated.

10 (4) "Consortium" means the Maryland Consortium on Coordinated
11 Community Supports established under subsection (b) of this section.

12 **(L) (1) THE CONSORTIUM SHALL DEVELOP GUIDELINES FOR**
13 **DEVELOPING A STANDARDIZED QUESTIONNAIRE TO IDENTIFY STUDENTS WITH**
14 **BEHAVIORAL HEALTH SERVICES NEEDS.**

15 **(2) THE GUIDELINES SHALL BE:**

16 **(i) DEVELOPED IN CONSULTATION WITH THE FOLLOWING**
17 **STAKEHOLDERS SELECTED BY THE CHAIR OF THE CONSORTIUM:**

18 1. **ONE MEMBER OF THE MARYLAND OPTOMETRIC**
19 **ASSOCIATION;**

20 2. **ONE MEMBER OF THE STATE TRAUMATIC BRAIN**
21 **INJURY ADVISORY BOARD;**

22 3. **ONE MEMBER OF THE MARYLAND ASSOCIATION OF**
23 **SCHOOL HEALTH NURSES;**

24 4. **ONE MEMBER OF THE DIVISION OF EARLY**
25 **INTERVENTION AND SPECIAL EDUCATION SERVICES IN THE DEPARTMENT;**

26 5. **ONE MEMBER OF THE MARYLAND ACADEMY OF**
27 **AUDIOLOGY;**

28 6. **ONE MEMBER OF THE MARYLAND ASSOCIATION OF**
29 **NONPUBLIC SPECIAL EDUCATION FACILITIES;**

30 7. **ONE EXPERT IN EARLY CHILDHOOD TRAUMA AND**
31 **DEVELOPMENT;**

- 1 **8. ONE EXPERT ON DATA PROTECTION; AND**
- 2 **9. ANY OTHER INDIVIDUAL SELECTED BY THE CHAIR;**
- 3 **(II) DEVELOPED USING AN EVIDENCE-BASED MEASUREMENT**
- 4 **APPROACH; AND**
- 5 **(III) UPDATED EVERY 5 YEARS.**

6 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
7 1, 2023.
