- 3 1 (b) (1) A qualified film production entity may claim a credit against the State 2 income tax for film production activities in the State in an amount equal to the amount 3 stated in the final tax credit certificate approved by the Secretary for film production 4 activities. 5 (2)If the tax credit allowed under this section in any taxable year exceeds 6 the total tax otherwise payable by the qualified film production entity for that taxable year, 7 the qualified film production entity may claim a refund in the amount of the excess. 8 Except as provided in paragraph (2) of this subsection, the Secretary (1)9 may not issue tax credit certificates for credit amounts in the aggregate totaling more than: (i) for fiscal year 2014, \$25,000,000; 10 for fiscal year 2015, \$7,500,000; 11 (ii) 12 (iii) for fiscal year 2016, \$7,500,000; 13 for fiscal year 2019, \$8,000,000; (iv) 14 (v) for fiscal year 2020, \$11,000,000; [and] 15 (vi) for EACH OF fiscal [year] YEARS 2021 [and each fiscal year thereafter] THROUGH 2023, \$12,000,000; 16 (VII) FOR FISCAL YEAR 2024, \$25,000,000; AND 17 18 (VIII) FOR FISCAL 2025YEAR AND EACH FISCAL YEAR 19 THEREAFTER, \$50,000,000. 20 If the aggregate credit amounts under the tax credit certificates issued by the Secretary total less than the maximum provided under paragraph (1) of this 21 22subsection in any fiscal year, any excess amount may be carried forward and issued under 23 tax credit certificates in a subsequent fiscal year.
- 24The Secretary may not issue tax credit certificates for credit amounts totaling more than \$10,000,000 in the aggregate for a single film production activity. 25
- 26 For fiscal year 2019 and each fiscal year thereafter, the Secretary **(4)** (i) 27 shall make 10% of the credit amount authorized under paragraph (1) of this subsection 28 available for Maryland small or independent film entities.
- 29 If the total amount of credits applied for by Maryland small or (ii) independent film entities is less than the amount made available under subparagraph (i) 30 of this paragraph, the Secretary shall make available the unused amount of credits for use 31 32 by qualified film production entities.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2023, and shall be applicable to all taxable years beginning after December 31, 2022.
