A BILL ENTITLED

1 AN ACT concerning

2 **Perfusionists – Licensure Exemption – Employees and Agents of Federally**
3 **Designated Organ Procurement Organizations**

4 FOR the purpose of exempting employees and agents of federally designated organ
5 procurement organizations who preserve or perfuse organs from deceased human
6 donors for certain purposes from licensure requirements for perfusionists; and
7 generally relating to perfusionists.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Health Occupations**

21 14–5E–01.

22 (a) In this subtitle the following words have the meanings indicated.

23 (e) “Licensed perfusionist” means a perfusionist who is licensed by the Board
24 under this subtitle to practice perfusion.

1 (f) (1) "Practice perfusion" means to perform the functions necessary for the
2 support, treatment, measurement, or supplementation of the cardiovascular, circulatory,
3 or respiratory systems, or other organs to ensure the safe management of physiologic
4 functions by monitoring and analyzing the parameters of the systems under an order and
5 the supervision of a licensed physician.

7 (a) Except as otherwise provided in this subtitle, on or after October 1, 2013, an
8 individual shall be licensed by the Board before the individual may practice perfusion in
9 this State.

10 (b) This section does not apply to [a]:

11 (1) A student enrolled in an education program under § 14-5E-09(c)(2) of
12 this subtitle while practicing perfusion in that program; OR

13 (2) AN INDIVIDUAL WHO:

14 (I) IS AN EMPLOYEE OR AGENT OF A FEDERALLY DESIGNATED
15 ORGAN PROCUREMENT ORGANIZATION, WHILE ACTING WITHIN THE SCOPE OF THAT
16 EMPLOYMENT; AND

17 (II) WHILE ACTING AS AN EMPLOYEE OR AGENT OF A
18 FEDERALLY DESIGNATED PROCUREMENT ORGANIZATION, PRESERVES OR
19 PERFUSES AN ORGAN FROM A DECEASED HUMAN DONOR FOR THE PURPOSE OF:

20 1. TRANSPLANTATION;

21 2. THERAPY;

22 3. RESEARCH; OR

23 4. EDUCATION.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 October 1, 2023.
