3 (d) "Office" means the Office of Home Energy Programs.

4 5-5A-07.

5 (a) (1) The Office shall:

6 (i) carry out an energy emergency crisis intervention program to
7 prevent low-income households, including the near poor, the elderly, households with
8 children, and those on fixed incomes from experiencing danger to health or survival as a
9 result of an energy emergency;

10 (ii) establish intake procedures for those experiencing an energy
11 emergency;

12 (iii) establish guidelines for the income and program eligibility of
13 applicants; and

14 (iv) identify local public or private agencies to administer the crisis
15 intervention program.

16 (2) (i) The Office shall make payments to fuel vendors and utility
17 vendors that have provided service to persons qualifying for the crisis intervention
18 program.

19 (ii) The amount of assistance shall be based on need.

20 (b) (1) The Office shall carry out one or more fuel and utility assistance
21 programs to make payments on behalf of qualified households to defray fuel and utility
22 costs.

23 (2) (I) The Office shall determine program and income eligibility
24 guidelines.

25 (II) **THE OFFICE SHALL ENROLL IN ANY FUEL AND UTILITY**
26 **ASSISTANCE PROGRAM ANY HOUSEHOLD WITH AN INDIVIDUAL WHO MEETS THE**
27 **FINANCIAL ELIGIBILITY REQUIREMENTS ESTABLISHED BY THE DEPARTMENT FOR A**
28 **RECIPIENT OF:**

29 **1. THE SUPPLEMENTAL NUTRITION ASSISTANCE**
30 **PROGRAM;**

31 **2. TEMPORARY ASSISTANCE FOR NEEDY FAMILIES;**

1 **3. SUPPLEMENTAL SECURITY INCOME; OR**

2 **4. MEANS-TESTED VETERANS AFFAIRS BENEFITS.**

3 (3) The amount of assistance shall be based on need.

4 (c) For fiscal year 2023 only, the Governor shall appropriate to the Office an
5 amount equal to the unexpended appropriation to the Office for fiscal year 2021 funding
6 that was included in Supplemental Budget No. 5.

9 (a) (1) The Commission shall establish an electric universal service program
10 to assist electric customers with annual incomes[:

11 (i) at or below 175% of the federal poverty level; or

12 (ii) for a customer at least 67 years of age,] at or below 200% of the
13 federal poverty level.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 ~~October 1, 2023~~ January 1, 2024.
