## Education - Public School Athletics - Basketball Schedule

FOR the purpose of establishing rules for public school athletic schedules for basketball, including the maximum number of games played per week and season and the number of tournament games played each year; requiring each county board of education to decide whether to authorize a team to play in a tournament or showcase game; prohibiting a student from being disciplined for not participating in a game or practice that occurs outside of the school year; and generally relating to the basketball schedule for public schools.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

[^0](A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
(2) "GAME" MEANS A SINGLE SPORTS COMPETITION BETWEEN TWO TEAMS.
(3) "Tournament" Means a series of games that make up a SINGLE UNIT OF COMPETITION IN WHICH MULTIPLE TEAMS PLAY UNTIL ONE TEAM WINS.
(B) ALL PUBLIC SCHOOL ATHLETIC SCHEDULES FOR BASKETBALL SHALL COMPLY WITH THIS SECTION.
(C) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A BASKETBALL TEAM MAY NOT PLAY MORE THAN TWO GAMES PER WEEK.
(2) A team may elect to play three games per week twice DURING THE BASKETBALL SEASON.
(D) (1) THE BASKETBALL SEASON SHALL CONSIST OF:
(I) 20 REGULAR SEASON GAMES FOR A TEAM THAT ELECTS TO PLAY IN A TOURNAMENT; AND
(II) 22 REGULAR SEASON GAMES FOR A TEAM THAT DOES NOT ELECT TO PLAY IN A TOURNAMENT.
(2) THE BASKETBALL SEASON DOES NOT INCLUDE GAMES PLAYED AS PART OF A TOURNAMENT.
(E) (1) (I) SUBJECT TO PARAGRAPHS (2) AND (3), (3), AND (4) OF THIS SUBSECTION, IN ADDITION TO THE REGULAR SEASON GAMES AUTHORIZED UNDER SUBSECTION (D)(1) OF THIS SECTION, EACH YEAR A TEAM MAY PLAY IN UP TO FOUR TOURNAMENT GAMES AND A NUMBER OF SHOWCASE GAMES DETERMINED BY THE county board, including during a NCAA Evaluation Period.
(II) A TOURNAMENT OR SHOWCASE MAY BE SCHEDULED OUTSIDE THE NORMAL BASKETBALL SEASON.
(III) A State team may play in a tournament or showcase GAME AGAINST A TEAM FROM OUTSIDE THE STATE IF THE OUT-OF-STATE TEAM HAS EQUIVALENT QUALIFICATIONS TO THOSE REQUIRED OF THE STATE TEAM.
(2) (I) EACH COUNTY BOARD SHALL DECIDE WHETHER TO AUTHORIZE A TEAM TO PLAY IN A TOURNAMENT.
(II) A COUNTY BOARD MAY AUTHORIZE A TEAM TO:

1. PLAY IN AN ALREADY SCHEDULED TOURNAMENT; OR
2. PLAY IN A TOURNAMENT SCHEDULED BY THE COUNTY BOARD.
(3) (I) EACH COUNTY BOARD SHALL DECIDE WHETHER TO AUTHORIZE A TEAM TO PLAY IN SHOWCASE GAMES.
(II) A COUNTY BOARD MAY AUTHORIZE A TEAM TO:
3. Play in an already scheduled showcase game OR SERIES OF GAMES; OR
4. PLAY IN SHOWCASE GAMES SCHEDULED BY A COUNTY BOARD.
(III) A COUNTY BOARD MAY AUTHORIZE TEAMS TO PLAY IN ANY NUMBER OF SHOWCASE GAMES.
(4) A STUDENT MAY NOT BE DISCIPLINED IN ANY MANNER, INCLUDING THROUGH THE LOSS OR REASSIGNMENT OF A STUDENT'S POSITION ON THE TEAM, FOR NOT PARTICIPATING IN A GAME OR PRACTICE THAT OCCURS OUTSIDE OF THE SCHOOL YEAR.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2023.
