# A BILL ENTITLED

## 1 AN ACT concerning

# Montgomery County - Village of Friendship Heights Special Taxing District Procurement

#### MC 15-23

- 5 FOR the purpose of increasing the threshold amount above which the Friendship Heights 6 Village Council is prohibited from entering into a certain contract without a 7 competitive bidding process; authorizing the village council to enter into a certain 8 contract that exceeds the threshold amount without a competitive bidding process if 9 the procurement is in response to an emergency; and generally relating to 10 procurement in the Village of Friendship Heights special taxing district.

# Article 16 – Montgomery County

19 Sec. 66–10.

# (a) [The] EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, THE "Friendship Heights Village Council" may not expend for material or work a sum exceeding [\$5,000] \$20,000 without having first advertised the specifications therefor and inviting bids for it, after which the village council may purchase whatever material or make contract for work or have the work done by employed labor or otherwise, as it may deem best.

#### HOUSE BILL 377

1 (b) **(1)** IN THIS SUBSECTION, "EMERGENCY" MEANS AN OCCURRENCE OR 2 CONDITION THAT:

3 (I) THE VILLAGE COUNCIL REASONABLY COULD NOT FORESEE; 4 AND

5 (II) REQUIRES AN ACTION TO AVOID OR MITIGATE SERIOUS 6 DAMAGE TO PUBLIC HEALTH, SAFETY, OR WELFARE.

### 7 (2) THE VILLAGE COUNCIL, BY MAJORITY VOTE, MAY ENTER INTO A 8 CONTRACT EXCEEDING \$20,000 WITHOUT SEEKING COMPETITIVE BIDS IF THE 9 PROCUREMENT IS IN RESPONSE TO AN EMERGENCY.

10 (C) The village council may engage in cooperative procurement with other 11 governmental entities in Montgomery County.

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 13 October 1, 2023.
