THE COMMISSIONER TAKES THIS EVALUATION 21INTO ACCOUNT WHEN DECIDING ON CERTAIN APPLICATIONS SUBMITTED FOR APPROVAL BY THE OFFICE OF FINANCIAL REGULATION. YOUR INVOLVEMENT IS 22ENCOURAGED. YOU MAY OBTAIN A COPY OF OUR EVALUATION. YOU MAY ALSO 23SUBMIT SIGNED, WRITTEN COMMENTS ABOUT OUR PERFORMANCE IN MEETING THE 24FINANCIAL SERVICES NEEDS OF THE COMMUNITY TO THE OFFICE OF FINANCIAL 2526 REGULATION.".

- 29 (1) IN THE PUBLIC LOBBY OF A REGULATED FINANCIAL INSTITUTION; 30 AND
- 31 (2) ON THE WEBSITE OF THE REGULATED FINANCIAL INSTITUTION.

HOUSE BILL 392

- 1 (A) (1) THE COMMISSIONER SHALL ADOPT REGULATIONS TO CARRY OUT $2\,$ THIS SUBTITLE.
- 3 (2) THE REGULATIONS SHALL INCLUDE EXAMINATION AND SUBTEST 4 CRITERIA FOR THE WRITTEN EVALUATION REQUIRED IN § 1–505 OF THIS SUBTITLE.

- 6 (1) ALTER THE RATING CATEGORIES IN § 7 1–504(A) OF THIS SUBTITLE OR ADD A POINT SCALE; AND
- 8 (2) ADOPT PROVISIONS OF THE FEDERAL COMMUNITY 9 REINVESTMENT ACT AND REGULATIONS ADOPTED UNDER THAT ACT.
