BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND. 13 That the Laws of Maryland read as follows: 14 Article - Education 15 12-102.Each member of the Board: 16 (h) (1) 17 (i) Serves without compensation; and 18 (ii) Is entitled to reimbursement for expenses in accordance with the Standard State Travel Regulations. 19 20(2)(i) The Board may [grant] AUTHORIZE A STUDENT MEMBER TO 21**RECEIVE:**
