CHAPTER _____

1 AN ACT concerning

2 **Gaming – Video Lottery Terminals – Local Impact Grants – Baltimore City**

3 FOR the purpose of altering the distribution of certain funds from local impact grants to
4 Baltimore City; and generally relating to the distribution of proceeds from video
5 lottery terminals and local impact grants.

6 BY repealing and reenacting, with amendments,
7 Article – State Government
8 Section 9–1A–31(a)
9 Annotated Code of Maryland
10 (2021 Replacement Volume and 2022 Supplement)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – State Government**

14 9–1A–31.

15 (a) (1) Except as provided in paragraph (8) of this subsection, the local impact
16 grants provided under § 9–1A–27 of this subtitle shall be distributed as provided in this
17 subsection.

18 (2) The following amounts shall be distributed to the following
19 jurisdictions:

- 1 (i) Allegany County – \$200,000;
- 2 (ii) Cecil County – \$130,000;
- 3 (iii) Town of Forest Heights – \$120,000;
- 4 (iv) Town of Perryville – \$70,000; and
- 5 (v) Worcester County – \$200,000.

6 (3) The remaining funds for local impact grants shall be distributed in the
7 following manner:

8 (i) 82% to the local jurisdictions with video lottery facilities, based
9 on each jurisdiction's percentage of overall gross revenues from video lottery terminals; and

10 (ii) except as provided in paragraph (4) of this subsection, for
11 operations at a video lottery facility starting in fiscal year 2012 and ending in fiscal year
12 2032, 18% to Baltimore City with the Pimlico Community Development Authority acting
13 as the local development council in accordance with subsection (d) of this section, to be
14 distributed primarily for capital projects benefiting economic and community development
15 in the following manner:

16 1. **A. FOR FISCAL YEARS 2012 THROUGH 2023**, at
17 least 75% in a manner that is consistent with the Park Heights Master Plan; and

18 **B. FOR FISCAL YEARS 2024 THROUGH 2032, 85% IN A**
19 **MANNER THAT IS CONSISTENT WITH THE PARK HEIGHTS MASTER PLAN; AND**

20 2. the remainder dedicated to the needs of:

21 A. any census blockgroup that Baltimore City identifies as
22 being located partly or entirely within 1 mile of Pimlico Race Course but not within the
23 boundaries of the Park Heights Master Plan in a manner that is consistent with adopted
24 neighborhood priorities;

25 B. any neighborhood included in the Northwest Community
26 Planning Forum Strategic Neighborhood Action Plan in a manner that is consistent with
27 the adopted Northwest Community Planning Forum Strategic Neighborhood Action Plan
28 priorities; and

29 C. beginning after a video lottery operation license is issued
30 to a video lottery facility in Baltimore City, any neighborhood within an area bounded by
31 Liberty Heights Avenue, Northern Parkway, Druid Park Drive, and Wabash Avenue in a
32 manner that is consistent with adopted neighborhood priorities.

1 (4) (i) Of the amount specified under paragraph (3)(ii) of this
2 subsection:

3 1. \$1,000,000 shall be provided annually to Prince George's
4 County to be used for public safety projects in the community within 5 miles surrounding
5 Rosecroft Raceway;

6 2. \$500,000 shall be provided annually for impact aid to be
7 distributed as provided under § 11-404(d) of the Business Regulation Article to help pay
8 for facilities and services in communities within 3 miles of the Laurel Race Course;

9 3. for fiscal years 2022 through 2032, \$3,500,000 shall be
10 provided annually to the State Lottery Fund established under § 9-120 of this title; and

11 4. for fiscal years 2021 through 2032, the greater of
12 \$2,400,000 or 24% of the total amount distributed for the fiscal year under paragraph (3)(ii)
13 of this subsection shall be provided annually to Park Heights Renaissance, Inc.

14 (ii) The Legislative Policy Committee shall report its findings and
15 recommendations concerning the advisability of the continuation of the distribution of
16 funds after fiscal year 2032 to the Comptroller and, in accordance with § 2-1257 of this
17 article, the General Assembly, on or before November 1, 2030.

18 (5) Anne Arundel County, Howard County, Prince George's County, and
19 the City of Laurel shall report to the Legislative Policy Committee, in accordance with §
20 2-1257 of this article, by December 31 of each year as to the distribution of the funds
21 provided under this section.

22 (6) Baltimore City shall:

23 (i) except as provided in subsection (b)(3)(i) of this section, establish
24 a schedule for the distribution and expenditure of funds provided under this section; and

25 (ii) provide a quarterly report to the Legislative Policy Committee,
26 in accordance with § 2-1257 of this article, on the distribution of the funds provided under
27 this section.

28 (7) (i) The distribution under paragraph (3)(i) of this subsection to
29 Anne Arundel County, Baltimore City, and Prince George's County equals the sum of the
30 amounts to be distributed to Anne Arundel County, Baltimore City, and Prince George's
31 County divided by three.

32 (ii) 1. Notwithstanding subparagraph (i) of this paragraph, the
33 amount distributed to Anne Arundel County and Baltimore City under paragraph (3)(i) of
34 this subsection may not be less than the amount received in the fiscal year before the video
35 lottery operation license for a video lottery facility in Prince George's County was issued.

1 2. Any amount distributed to Anne Arundel County or
2 Baltimore City as required under subparagraph 1 of this subparagraph shall be paid
3 from the State Lottery Fund established under § 9–120(b) of this title.

4 (8) Beginning after a video lottery operation license is issued to a video
5 lottery facility in Baltimore City, 100% of the local impact grants provided under §
6 9–1A–27 of this subtitle from the proceeds of the video lottery facilities located in Allegany,
7 Cecil, and Worcester counties shall be distributed to the local jurisdictions in which those
8 video lottery facilities are located.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
10 1, 2023.
