A1 3lr1458 CF SB 431 By: Washington County Delegation Introduced and read first time: February 3, 2023 Assigned to: Economic Matters Committee Report: Favorable with amendments House action: Adopted Read second time: March 11, 2023 CHAPTER AN ACT concerning Alcoholic Beverages - Class 9 Limited Distillery License - Self-Distribution FOR the purpose of authorizing a holder of a Class 9 limited distillery license to sell and deliver alcoholic beverages manufactured under the license in bulk to a person in the State that is authorized to acquire them and to a person outside the State that is authorized to acquire them; repealing the prohibition against a holder of a Class 9 limited distillery license applying for or possessing a wholesaler's license to apply for and obtain a Class 8 liquor wholesaler's license with certain privileges; and generally relating to Class 9 limited distillery licenses. BY repealing and reenacting, with amendments, Article – Alcoholic Beverages Section 2–203, 2–212(b), 2–308.1, and 2–311 Annotated Code of Maryland (2016 Volume and 2022 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Alcoholic Beverages 2-203.(a) There is a Class 9 limited distillery license.
