5 the Maryland Higher Education Commission; and generally relating to the Access to
6 Mental Health Advisory Committee.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 **11–108.**

16 **(A) THERE IS AN ACCESS TO MENTAL HEALTH ADVISORY COMMITTEE.**

1 **(B) THE COMMITTEE CONSISTS OF THE FOLLOWING MEMBERS:**

2 **(1) THE SECRETARY OF HIGHER EDUCATION, OR THE SECRETARY'S**
3 **DESIGNEE;**

4 **(2) THE CHANCELLOR OF THE UNIVERSITY SYSTEM OF MARYLAND,**

1 **(I) ONE STUDENT WHO IS A MEMBER OF A MENTAL HEALTH**
2 **ADVOCACY GROUP; AND**

3 **(II) ONE STUDENT WHO HAS ACCESSED, OR IS ELIGIBLE TO**
4 **ACCESS, MENTAL HEALTH SERVICES AT THE INSTITUTION; AND**

5 **(13) ONE STUDENT REPRESENTATIVE ENROLLED IN ST. MARY'S**
6 **COLLEGE OF MARYLAND, MORGAN STATE UNIVERSITY, A COMMUNITY COLLEGE,**
7 **OR A NONPROFIT INSTITUTION OF HIGHER EDUCATION IN THE STATE.**

8 **(C) (1) THE COMMITTEE SHALL ELECT A CHAIR FROM AMONG ITS**
9 **MEMBERS.**

10 **(2) THE COMMITTEE MAY ELECT OTHER OFFICERS AS DETERMINED**
11 **BY THE COMMITTEE.**

12 **~~THE COMMISSION SHALL PROVIDE~~ (D) THE COMMITTEE SHALL**
13 **BE PROVIDED ON A ROTATING BASIS BY THE INSTITUTIONS OF HIGHER EDUCATION**
14 **THAT HAVE MEMBERS ON THE COMMITTEE.**

15 **(E) THE COMMITTEE SHALL MEET SIX TIMES PER YEAR.**

16 **(F) A MEMBER OF THE COMMITTEE:**

17 **(1) MAY NOT RECEIVE COMPENSATION AS A MEMBER OF THE**
18 **COMMITTEE; BUT**

19 **(2) IS ENTITLED TO REIMBURSEMENT FOR EXPENSES UNDER THE**
20 **STANDARD STATE TRAVEL REGULATIONS, AS PROVIDED IN THE STATE BUDGET.**

21 **(G) THE COMMITTEE SHALL:**

22 **(1) STUDY THE POLICIES AND PROCEDURES ADOPTED BY**
23 **INSTITUTIONS OF HIGHER EDUCATION IN THE STATE REGARDING ACCESS TO**
24 **MENTAL HEALTH CARE AND THE PREVENTION AND TREATMENT OF MENTAL**
25 **ILLNESS IN STUDENTS;**

26 **(2) EXAMINE THE CHALLENGES FOR INSTITUTIONS OF HIGHER**
27 **EDUCATION IN MEETING THE DEMAND FOR MENTAL HEALTH SERVICES;**

28 **(3) REVIEW BEST PRACTICES FOR ACCESSING OFF-CAMPUS MENTAL**
29 **HEALTH SERVICES;**

1 **(4) REVIEW BEST PRACTICES FOR, AND BARRIERS TO, THE**
2 **IMPLEMENTATION OF COUNSELING SERVICES, INCLUDING CRISIS, PERSONAL,**
3 **MENTAL HEALTH, SEXUAL VIOLENCE, AND SUBSTANCE ABUSE COUNSELING;**

4 **(5) REVIEW AND IDENTIFY THE BEST MODELS FOR PROVIDING**
5 **MENTAL HEALTH SERVICES, INCLUDING STAND-ALONE CENTERS, CENTERS WITH**
6 **INTEGRATED STUDENT HEALTH SERVICES, COMPREHENSIVE SERVICES, CASE**
7 **MANAGEMENT, AND CRISIS RESOURCES;**

8 **(6) IDENTIFY CONCERNS IN RURAL AREAS AND WORKFORCE**
9 **SHORTAGE AREAS;**

10 **(7) MAKE RECOMMENDATIONS REGARDING:**

11 **(i) WAYS TO REDUCE COSTS AND BARRIERS TO PROVIDING**
12 **ACCESS TO MENTAL HEALTH SERVICES ON CAMPUS;**

13 **(ii) THE USE OF TELEMEDICINE AND VIDEO CONFERENCING IN**
14 **THE PROVISION OF MENTAL HEALTH SERVICES;**

15 **(iii) THE USE OF HOTLINES AND OTHER MEANS TO DISSEMINATE**
16 **TO STUDENTS INFORMATION RELATED TO MENTAL HEALTH SERVICES ON AND OFF**
17 **CAMPUS, INCLUDING INFORMATION CONCERNING AVAILABILITY AND FEES; AND**

18 **(iv) THE IMPLEMENTATION OF GENERAL MENTAL HEALTH**
19 **COUNSELING SERVICES AND SPECIALIZED COUNSELING SERVICES; AND**

20 **(8) STUDY AND MAKE RECOMMENDATIONS REGARDING ANY OTHER**
21 **MATTERS THE COMMITTEE CONSIDERS APPROPRIATE.**

22 **(H) ON OR BEFORE DECEMBER 1, 2023, ~~AND EACH DECEMBER 1~~**
23 **~~THEREAFTER,~~ THE COMMITTEE SHALL REPORT ITS FINDINGS AND**
24 **RECOMMENDATIONS TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1257 OF**
25 **THE STATE GOVERNMENT ARTICLE, THE SENATE BUDGET AND TAXATION**
26 **COMMITTEE, THE SENATE EDUCATION, ENERGY, AND THE ENVIRONMENT**
27 **COMMITTEE, THE HOUSE WAYS AND MEANS COMMITTEE, AND THE HOUSE**
28 **APPROPRIATIONS COMMITTEE.**

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
30 1, 2023.
