9 10 11 12	(d) (C) (1) Subject to [paragraph] PARAGRAPHS (2) AND (3) of this subsection, a license holder who holds a valid Class B–D–7 beer, wine, and liquor license issued on or before July 1, 2018, may apply to the Board to exchange the license for a Class A–7 license if the license holder first obtains approval by resolution of the Baltimore City Council.
$13 \\ 14 \\ 15 \\ 16 \\ 17$	(2) Notwithstanding paragraph (3) of this subsection, a <u>A</u> license holder who holds a valid Class B–D–7 beer, wine, and liquor license for premises located on the odd side of the 4000 block of Frederick Avenue may apply to the Board to exchange the license for a Class A–7 license.
18	(3) The Board may not issue a Class A-7 license on or after July 1, 2022.
19 20	(e) (D) A holder of a Class A–7 license may sell beer, wine, and liquor on Monday through Sunday from 10 a.m. to midnight.
21	(f) (E) The annual license fee is \$1,500.
22 23 24 25	SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2023. It shall remain effective for a period of 1 year and, at the end of June 30, 2024, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
