CHAPTER _____

1 AN ACT concerning

2 **Human Relations – Housing Discrimination – Service Dogs ~~and Guide Dogs~~**

3 FOR the purpose of prohibiting a person from discriminating in the sale or rental of, or
4 otherwise making unavailable or denying, a dwelling to an individual with a
5 disability who has, obtains, or retains a certain service dog ~~or guide dog~~; and
6 generally relating to discrimination in housing.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – State Government**

15 20-706.

1 (a) **(1)** In this section, ~~“covered”~~ **THE FOLLOWING WORDS HAVE THE**
 2 **MEANINGS INDICATED.**

3 **(2)** **“COVERED multifamily dwelling”** means:

4 ~~(1)~~ **(I)** a building consisting of four or more units, if the building has one
 5 or more elevators; or

6 ~~(2)~~ **(II)** a ground floor unit in a building consisting of four or more units,
 7 if the building has no elevator.

8 **(3)** **(I)** **“SERVICE DOG” MEANS A DOG THAT IS INDIVIDUALLY**
 9 **TRAINED TO DO WORK OR PERFORM TASKS FOR THE BENEFIT OF AN INDIVIDUAL**
 10 **WITH A DISABILITY.**

11 **(II)** **“SERVICE DOG” DOES NOT INCLUDE A DOG THAT:**

12 **1. AS A RESULT OF THE ANIMAL’S PRESENCE, IS MEANT**
 13 **TO DETER CRIME; OR**

14 **2. PROVIDES ONLY EMOTIONAL SUPPORT, WELL-BEING,**
 15 **COMFORT, OR COMPANIONSHIP TO AN INDIVIDUAL.**

16 (b) Except as provided in §§ 20–703 and 20–704 of this subtitle, a person may not:

17 (1) discriminate in the sale or rental of, or otherwise make unavailable or
 18 deny, a dwelling to any buyer or renter because of a disability of:

19 (i) the buyer or renter; or

20 (ii) an individual residing in or intending to reside in the dwelling
 21 after it is sold, rented, or made available;

22 (2) discriminate against any individual in the terms, conditions, or
 23 privileges of the sale or rental of a dwelling, or in the provision of services or facilities in
 24 connection with the dwelling, because of a disability of:

25 (i) the individual; or

26 (ii) an individual residing in or intending to reside in the dwelling
 27 after it is sold, rented, or made available;

28 (3) refuse to allow, at the expense of an individual with a disability,
 29 reasonable modifications of existing premises occupied or to be occupied by the individual,
 30 if:

1 (i) the modifications may be necessary to afford the individual with
2 a disability full enjoyment of the dwelling; and

3 (ii) for a rental dwelling, the tenant agrees that, when the tenant
4 vacates the dwelling, the tenant will restore, at the tenant's expense, the interior of the
5 dwelling to the condition that existed before the modification, except for reasonable wear
6 and tear;

7 (4) refuse to make reasonable accommodations in rules, policies, practices,
8 or services when the accommodations may be necessary to afford an individual with a
9 disability equal opportunity to use and enjoy a dwelling; [or]

10 (5) fail to design or construct a covered multifamily dwelling for first
11 occupancy as required under subsection (c) of this section; **OR**

12 **(6) DISCRIMINATE IN THE SALE OR RENTAL OF, OR OTHERWISE MAKE**
13 **UNAVAILABLE OR DENY, A DWELLING TO AN INDIVIDUAL WITH A DISABILITY WHO:**

14 **(I) HAS OR OBTAINS A SERVICE DOG ~~OR GUIDE DOG~~; OR**

15 **(II) RETAINS THE INDIVIDUAL'S FORMER SERVICE DOG ~~OR~~**
16 **~~GUIDE DOG AS A PET AFTER ITS RETIREMENT FROM SERVICE.~~**

17 (c) (1) On or after July 1, 1991, a covered multifamily dwelling for first
18 occupancy shall be designed and constructed so that:

19 (i) the public use and common use portions of the dwelling are
20 readily accessible and usable to individuals with disabilities;

21 (ii) all the doors designed to allow passage into and within all
22 premises within the dwelling are sufficiently wide to allow passage by individuals with
23 disabilities in wheelchairs; and

24 (iii) all premises within the dwelling contain the following features of
25 adaptive design:

26 1. an accessible route into and through the dwelling;

27 2. light switches, electrical outlets, thermostats, and other
28 environmental controls in accessible locations;

29 3. reinforcements in bathroom walls to allow later
30 installation of grab bars; and

1 4. usable kitchens and bathrooms so that an individual in a
2 wheelchair can maneuver about the space.

3 (2) The requirements of paragraph (1) of this subsection are satisfied by
4 compliance with:

5 (i) the appropriate requirements of the most current revision of the
6 American National Standard for Buildings and Facilities Providing Accessibility and
7 Usability for Physically Handicapped People (commonly cited as ANSI A117.1); or

8 (ii) the federal law, regulations, and guidelines on handicapped
9 accessibility adopted under the federal Fair Housing Amendments Act of 1988 and
10 incorporated by reference in the regulations adopted by the Department of Housing and
11 Community Development under § 12–202 of the Public Safety Article.

12 **(D) AN INDIVIDUAL WITH A DISABILITY WHO HAS, OBTAINS, OR RETAINS A**
13 **SERVICE DOG ~~OR GUIDE DOG~~ AS PROVIDED IN SUBSECTION (B)(6) OF THIS SECTION:**

14 **(1) SHALL BE EXEMPT FROM ANY PROVISION IN A LEASE OR RENTAL**
15 **AGREEMENT PROHIBITING THE KEEPING OF DOGS;**

16 **(2) MAY NOT BE REQUIRED TO PAY ANY ADDITIONAL RENT OR FEE**
17 **FOR THE INDIVIDUAL'S SERVICE DOG OR FORMER SERVICE DOG; ~~AND~~**

18 **(3) MAY KEEP THE INDIVIDUAL'S FORMER SERVICE DOG IN THE**
19 **DWELLING FOR THE LIFE OF THE SERVICE DOG AFTER ITS RETIREMENT FROM**
20 **SERVICE; AND**

21 ~~(3)~~ **(4) SHALL BE LIABLE FOR ANY DAMAGE DONE TO THE**
22 **PREMISES BY THE INDIVIDUAL'S SERVICE DOG OR FORMER SERVICE DOG.**

23 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
24 October 1, 2023.
