A BILL ENTITLED

1 AN ACT concerning

2 **Education – Holocaust Education Assistance Grant Program – Established**

3 FOR the purpose of establishing the Holocaust Education Assistance Grant Program in the
4 State Department of Education to assist local school systems with Holocaust
5 education in public schools; and generally relating to the establishment of the
6 Holocaust Education Assistance Grant Program.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 **7–132.**

16 **(A) IN THIS SECTION, “PROGRAM” MEANS THE HOLOCAUST EDUCATION**
17 **ASSISTANCE GRANT PROGRAM.**

18 **(B) (1) THERE IS A HOLOCAUST EDUCATION ASSISTANCE GRANT**
19 **PROGRAM IN THE STATE.**

20 **(2) THE PURPOSE OF THE PROGRAM IS TO ASSIST LOCAL SCHOOL**
21 **SYSTEMS WITH HOLOCAUST EDUCATION IN PUBLIC SCHOOLS.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 **(C) A LOCAL SCHOOL SYSTEM MAY APPLY TO THE DEPARTMENT FOR A**
2 **GRANT FROM THE PROGRAM.**

3 **(D) A LOCAL SCHOOL SYSTEM MAY USE A GRANT ONLY FOR**
4 **HOLOCAUST-RELATED:**

5 **(1) TEACHER TRAINING;**

6 **(2) TEACHING MATERIALS; OR**

7 **(3) TRIPS AND ACTIVITIES.**

8 **(E) (1) THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL**
9 **AN APPROPRIATION OF \$1,200,000 TO THE PROGRAM.**

10 **(2) NO LOCAL SCHOOL SYSTEM SHALL RECEIVE MORE THAN \$50,000**
11 **AS A GRANT FROM THE PROGRAM IN A FISCAL YEAR.**

12 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
13 1, 2023.
