10	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

14 15 16	(a) A person may file a petition listing relevant facts for expungement of a police record, court record, or other record maintained by the State or a political subdivision of the State if the person is convicted of:

- 26 (2) (i) Except as provided in subparagraph (ii) of this paragraph, if the proceeding began in one court and was transferred to another court, the person shall file the petition in the court to which the proceeding was transferred.

- 1 (ii) If the proceeding began in one court and was transferred to the 2 juvenile court under § 4–202 or § 4–202.2 of this article, the person shall file the petition in 3 the court of original jurisdiction from which the order of transfer was entered.
- 4 (3) (i) If the proceeding in a court of original jurisdiction was appealed to a court exercising appellate jurisdiction, the person shall file the petition in the appellate court.
- 7 (ii) The appellate court may remand the matter to the court of 8 original jurisdiction.
- 9 (c) (1) Except as provided in paragraphs (2), (3), and (4) of this subsection, a petition for expungement under this section may not be filed earlier than 10 years after the 11 person satisfies the sentence or sentences imposed for all convictions for which 12 expungement is requested, including parole, probation, or mandatory supervision.
- 13 (2) A petition for expungement for a violation of § 3–203 of the Criminal 14 Law Article, common law battery, or for an offense classified as a domestically related crime 15 under § 6–233 of this article may not be filed earlier than 15 years after the person satisfies 16 the sentence or sentences imposed for all convictions for which expungement is requested, 17 including parole, probation, or mandatory supervision.
- 18 (3) Except as provided in paragraph (4) of this subsection, a petition for expungement of a felony may not be filed earlier than 15 years after the person satisfies the sentence or sentences imposed for all convictions for which expungement is requested, including parole, probation, or mandatory supervision.
 - (4) A petition for expungement of a conviction of possession with intent to distribute cannabis under § 5–602 of the Criminal Law Article may not be filed earlier than 3 years after the person satisfies the sentence or sentences imposed for all convictions for which expungement is requested, including parole, probation, or mandatory supervision.
 - (d) (1) If the person is convicted of a new crime during the applicable time period set forth in subsection (c) of this section, the original conviction or convictions are not eligible for expungement unless the new conviction becomes eligible for expungement.
- 29 (2) A person is not eligible for expungement if the person is a defendant in 30 a pending criminal proceeding.
- 31 (3) If a person is not eligible for expungement of one conviction in a unit, 32 the person is not eligible for expungement of any other conviction in the unit.
- 33 (e) (1) The court shall have a copy of a petition for expungement served on the 34 State's Attorney.
- The court shall send written notice of the expungement request to each listed victim in the case in which the petitioner is seeking expungement at the address

- listed in the court file, advising the victim of the right to offer additional information relevant to the expungement petition to the court.
- 3 (3) Unless the State's Attorney or a victim files an objection to the petition 4 for expungement within 30 days after the petition is served, the court shall pass an order 5 requiring the expungement of all police records and court records about the charge.
- 6 (f) (1) If the State's Attorney or a victim files a timely objection to the petition, 7 the court shall hold a hearing.
- 8 (2) The court shall order the expungement of all police records and court 9 records about the charge after a hearing, if the court finds and states on the record:
- 10 (i) that the conviction is eligible for expungement under subsection 11 (a) of this section;
- 12 (ii) that the person is eligible for expungement under subsection (d) 13 of this section;
- 14 (iii) that giving due regard to the nature of the crime, the history and 15 character of the person, and the person's success at rehabilitation, the person is not a risk 16 to public safety; and
- 17 (iv) that an expungement would be in the interest of justice.
- 18 (g) If at a hearing the court finds that a person is not entitled to expungement, 19 the court shall deny the petition.
- 20 (h) Unless an order is stayed pending appeal, within 60 days after entry of the 21 order, every custodian of the police records and court records that are subject to the order 22 of expungement shall advise in writing the court and the person who is seeking 23 expungement of compliance with the order.
- 24 (i) (1) The State's Attorney is a party to the proceeding.
- 25 (2) A party aggrieved by the decision of the court is entitled to the appellate 26 review as provided in the Courts Article.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023.
