A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure – Expungement of Records – Good Cause**

3 FOR the purpose of authorizing a court to grant a petition for expungement of records
4 relating to a certain conviction at any time on a showing of good cause; and generally
5 relating to expungement of records.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
12 That the Laws of Maryland read as follows:

13 **Article – Criminal Procedure**

14 10–110.

15 (a) A person may file a petition listing relevant facts for expungement of a police
16 record, court record, or other record maintained by the State or a political subdivision of
17 the State if the person is convicted of:

18 (1) a misdemeanor that is a violation of:

19 (i) § 6–320 of the Alcoholic Beverages Article;

20 (ii) an offense listed in § 17–613(a) of the Business Occupations and
21 Professions Article;

13 (2) a felony that is a violation of:

14 (i) § 7-104 of the Criminal Law Article;

15 (ii) the prohibition against possession with intent to distribute a
16 controlled dangerous substance under § 5-602 of the Criminal Law Article; or

17 (iii) § 6-202(a), § 6-203, or § 6-204 of the Criminal Law Article; or

18 (3) an attempt, a conspiracy, or a solicitation of any offense listed in item
19 (1) or (2) of this subsection.

20 (b) (1) Except as provided in paragraphs (2) and (3) of this subsection, a person
21 shall file a petition for expungement in the court in which the proceeding began.

22 (2) (i) Except as provided in subparagraph (ii) of this paragraph, if the
23 proceeding began in one court and was transferred to another court, the person shall file
24 the petition in the court to which the proceeding was transferred.

25 (ii) If the proceeding began in one court and was transferred to the
26 juvenile court under § 4-202 or § 4-202.2 of this article, the person shall file the petition in
27 the court of original jurisdiction from which the order of transfer was entered.

28 (3) (i) If the proceeding in a court of original jurisdiction was appealed
29 to a court exercising appellate jurisdiction, the person shall file the petition in the appellate
30 court.

1 (ii) The appellate court may remand the matter to the court of
2 original jurisdiction.

3 (c) (1) Except as provided in paragraphs (2), (3), and (4) of this subsection, a
4 petition for expungement under this section may not be filed earlier than 10 years after the
5 person satisfies the sentence or sentences imposed for all convictions for which
6 expungement is requested, including parole, probation, or mandatory supervision.

7 (2) A petition for expungement for a violation of § 3–203 of the Criminal
8 Law Article, common law battery, or for an offense classified as a domestically related crime
9 under § 6–233 of this article may not be filed earlier than 15 years after the person satisfies
10 the sentence or sentences imposed for all convictions for which expungement is requested,
11 including parole, probation, or mandatory supervision.

12 (3) Except as provided in paragraph (4) of this subsection, a petition for
13 expungement of a felony may not be filed earlier than 15 years after the person satisfies
14 the sentence or sentences imposed for all convictions for which expungement is requested,
15 including parole, probation, or mandatory supervision.

16 (4) A petition for expungement of a conviction of possession with intent to
17 distribute cannabis under § 5–602 of the Criminal Law Article may not be filed earlier than
18 3 years after the person satisfies the sentence or sentences imposed for all convictions for
19 which expungement is requested, including parole, probation, or mandatory supervision.

20 **(5) A COURT MAY GRANT A PETITION FOR EXPUNGEMENT UNDER**
21 **THIS SECTION AT ANY TIME ON A SHOWING OF GOOD CAUSE.**

22 (d) (1) If the person is convicted of a new crime during the applicable time
23 period set forth in subsection (c) of this section, the original conviction or convictions are
24 not eligible for expungement unless the new conviction becomes eligible for expungement.

25 (2) A person is not eligible for expungement if the person is a defendant in
26 a pending criminal proceeding.

27 (3) If a person is not eligible for expungement of one conviction in a unit,
28 the person is not eligible for expungement of any other conviction in the unit.

29 (e) (1) The court shall have a copy of a petition for expungement served on the
30 State's Attorney.

31 (2) The court shall send written notice of the expungement request to each
32 listed victim in the case in which the petitioner is seeking expungement at the address
33 listed in the court file, advising the victim of the right to offer additional information
34 relevant to the expungement petition to the court.

1 (3) Unless the State's Attorney or a victim files an objection to the petition
2 for expungement within 30 days after the petition is served, the court shall pass an order
3 requiring the expungement of all police records and court records about the charge.

4 (f) (1) If the State's Attorney or a victim files a timely objection to the petition,
5 the court shall hold a hearing.

6 (2) The court shall order the expungement of all police records and court
7 records about the charge after a hearing, if the court finds and states on the record:

8 (i) that the conviction is eligible for expungement under subsection
9 (a) of this section;

10 (ii) that the person is eligible for expungement under subsection (d)
11 of this section;

12 (iii) that giving due regard to the nature of the crime, the history and
13 character of the person, and the person's success at rehabilitation, the person is not a risk
14 to public safety; and

15 (iv) that an expungement would be in the interest of justice.

16 (g) If at a hearing the court finds that a person is not entitled to expungement,
17 the court shall deny the petition.

18 (h) Unless an order is stayed pending appeal, within 60 days after entry of the
19 order, every custodian of the police records and court records that are subject to the order
20 of expungement shall advise in writing the court and the person who is seeking
21 expungement of compliance with the order.

22 (i) (1) The State's Attorney is a party to the proceeding.

23 (2) A party aggrieved by the decision of the court is entitled to the appellate
24 review as provided in the Courts Article.

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
26 October 1, 2023.
