- 23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 24That the Laws of Maryland read as follows:

Article - Business Regulation

- 2 (a) In this title the following words have the meanings indicated.
- 3 (O) (1) "PET REMAINS" MEANS THE BODY OF A DECEASED ANIMAL THAT 4 WAS KEPT AS A PET.
- 5 (2) "PET REMAINS" INCLUDES THE BODY OF A PET OR A PART OF A PET'S BODY IN ANY STATE OF DECOMPOSITION OR THE BODY OF A PET AFTER HAVING BEEN CREMATED.
- 8 [(o)] (P) (1) "Preneed goods" means burial goods that are sold before the 9 buyer's death.
- 10 (2) "Preneed goods" does not include burial space.
- 11 **[(p)] (Q)** "Provide burial goods" means a retail transaction:
- 12 (1) to erect, service, or inscribe burial memorials; or
- 13 (2) to sell burial goods.
- [(q)] (R) "Registered cemeterian" means an individual registered to operate a cemetery as a sole proprietor or on behalf of a sole proprietor or of a permit holder.
- 16 **[(r)] (S)** "Registered crematory operator" means an individual registered to operate a crematory as a sole proprietor or on behalf of a sole proprietor or permit holder.
- 18 **[(s)] (T)** "Registered seller" means an individual registered to provide burial goods as a sole proprietor or on behalf of a sole proprietor or of a permit holder.
- [(t)] (U) "Registration" means a registration issued by the Director authorizing an individual to operate a cemetery, to operate a crematory, or to provide burial goods.
- [(u)] (V) "Responsible party" means a sole proprietor or the individual designated by a partnership, limited liability company, or corporation to be responsible for the operations of a cemetery, crematory, or burial goods business.

- 26 (A) IN THIS SECTION, "PERPETUAL CARE" HAS THE MEANING STATED IN § 27 5–601 OF THIS TITLE.
- 28 (B) A REGISTERED CEMETERIAN, REGISTERED CREMATORY OPERATOR, OR 29 PERMIT HOLDER THAT ENGAGES IN THE OPERATION OF A CEMETERY, CREMATORY,

- 1 OR BURIAL GOODS BUSINESS WHO SELLS OR OFFERS TO SELL TO THE PUBLIC
- 2 CREMATION SERVICES, A BURIAL LOT, OR A BURIAL RIGHT IN A CEMETERY FOR PET
- 3 REMAINS AS TO WHICH PERPETUAL CARE IS STATED OR IMPLIED OWES A DUTY OF
- 4 PERPETUAL CARE FOR THE CEMETERY IN WHICH THE PET REMAINS ARE INTERRED.
- 5 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
