1 AN ACT concerning

2 **Recovery Residence Grant Program – Establishment**

3 FOR the purpose of establishing the Recovery Residence Grant Program within the
4 Maryland Department of Health to provide grants to recovery residences in the
5 State; and generally relating to the Recovery Residence Grant Program.

6 BY repealing and reenacting, without amendments,

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
17 That the Laws of Maryland read as follows:

18 **Article – Health – General**

2 (a) In this title the following words have the meanings indicated.

3 (n) “Peer support services” means a set of nonclinical activities provided by
4 individuals in recovery from mental disorders, substance–related disorders, or addictive
5 disorders who use their personal, lived experiences and training to support other
6 individuals with mental disorders, substance–related disorders, or addictive disorders.

7 (o) “Recovery residence” means a service that:

8 (1) Provides alcohol–free and illicit–drug–free housing to individuals with
9 substance–related disorders or addictive disorders or co–occurring mental disorders and
10 substance–related disorders or addictive disorders; and

11 (2) Does not include clinical treatment services.

13 (a) In this subtitle the following words have the meanings indicated.

14 (b) “Certificate of compliance” means a certificate that is issued to a recovery
15 residence by a credentialing entity.

16 (c) “Certified recovery residence” means a recovery residence that holds a
17 certificate of compliance.

18 (d) “Credentialing entity” means a nonprofit organization that develops and
19 administers professional certification programs according to nationally recognized
20 certification standards.

21 (e) “Recovery residence” has the meaning stated in § 7.5–101 of this article.

23 **(A) IN THIS SECTION, “PROGRAM” MEANS THE RECOVERY RESIDENCE**
24 **GRANT PROGRAM.**

25 **(B) (1) THERE IS A RECOVERY RESIDENCE GRANT PROGRAM IN THE**
26 **DEPARTMENT.**

27 **(2) THE PURPOSE OF THE PROGRAM IS TO PROVIDE GRANTS TO**
28 **RECOVERY RESIDENCES IN THE STATE IN ACCORDANCE WITH THIS SECTION.**

29 **(C) THE DEPARTMENT SHALL ADMINISTER THE PROGRAM.**

1 (D) THE PROGRAM SHALL AWARD COMPETITIVE GRANTS TO RECOVERY
2 RESIDENCES TO SUPPORT OPERATIONS, SERVICES, AND PROGRAMS.

3 (E) TO QUALIFY FOR A GRANT UNDER THE PROGRAM, A RECOVERY
4 RESIDENCE MUST:

5 (1) BE A NONPROFIT ORGANIZATION IN GOOD STANDING WITH THE
6 INTERNAL REVENUE SERVICE;

7 (2) SUBMIT A CURRENT COPY OF THE FORM 990 THAT THE
8 ORGANIZATION FILES WITH THE INTERNAL REVENUE SERVICE;

9 (3) BE CERTIFIED ~~AS A LEVEL II RECOVERY RESIDENCE BY THE~~

4 ~~(12) (4)~~ (4) NOT ACCEPT OR RECEIVE REIMBURSEMENT FROM PRIVATE
 5 INSURANCE OR THE MARYLAND MEDICAL ASSISTANCE PROGRAM; AND

6 (5) MEET ANY OTHER REQUIREMENT ESTABLISHED BY THE
 7 DEPARTMENT IN REGULATION.

8 (F) (1) THE DEPARTMENT SHALL ESTABLISH:

9 (I) APPLICATION PROCEDURES;

10 (II) CRITERIA FOR PRIORITIZING APPLICATIONS UNDER THE
 11 PROGRAM;

12 (III) PROCEDURES FOR AWARDING GRANTS UNDER THE
 13 PROGRAM; AND

14 (IV) ANY OTHER PROCEDURES OR CRITERIA NECESSARY TO
 15 CARRY OUT THIS SECTION.

16 (2) IN ESTABLISHING PROCEDURES AND CRITERIA UNDER THIS
 17 SUBSECTION, THE DEPARTMENT SHALL CONSULT THE CREDENTIALING ENTITY.

18 (G) FOR EACH OF FISCAL YEAR YEARS 2024 AND EACH FISCAL YEAR
 19 ~~THEREAFTER~~ THROUGH 2027, THE ANNUAL BUDGET BILL SHALL INCLUDE AN
 20 APPROPRIATION OF \$500,000 FOR THE PROGRAM.

21 (H) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2024, THE
 22 DEPARTMENT SHALL SUBMIT TO THE GOVERNOR AND, IN ACCORDANCE WITH §
 23 2-1257 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY A REPORT
 24 THAT INCLUDES, FOR THE MOST RECENT CLOSED FISCAL YEAR:

25 (1) THE NUMBER OF GRANTS DISTRIBUTED; AND

26 (2) INFORMATION ABOUT GRANT RECIPIENTS AND PROGRAMS AND
 27 SERVICES PROVIDED.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
 29 October 1, 2023.
