A BILL ENTITLED

1 AN ACT concerning

2 **Natural Resources – Apprentice Hunting License – Alterations**

3 FOR the purpose of authorizing the Department of Natural Resources to issue an
4 apprentice hunting license to a person under a certain age who has previously been
5 issued an apprentice hunting license under certain circumstances; and generally
6 relating to the apprentice hunting license.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Natural Resources**

20 10–301.

1 (d) A person who wishes to obtain a hunting license shall complete and submit an
2 application to the Department or to any person designated by the Department to issue a
3 hunting license.

4 (e) An applicant for a license issued under this section shall provide all the
5 information required by the Department, including the last four digits of the applicant's
6 Social Security number, if the applicant has a Social Security number.

7 (f) Before a hunting license may be issued the applicant for the license shall
8 acknowledge, as a component of the application, that a hunting license does not of itself
9 permit an individual to hunt on private property.

10 (g) (1) (I) There shall be the following types of hunting licenses in the
11 State[:].

12 [(i)] (II) 1. [A] THERE IS A resident hunting license that
13 enables the purchaser to hunt all legal game birds and mammals during any appropriate
14 season in Maryland without the purchase of additional stamps, unless the purchaser is
15 hunting migratory game birds or deer during bow and arrow season or black powder season.

16 2. To hunt migratory game birds the purchaser must also
17 buy a Maryland migratory game bird stamp and to hunt wild waterfowl the purchaser must
18 buy both a Maryland migratory game bird stamp and a federal migratory bird hunting and
19 conservation stamp.

20 3. To hunt deer during bow and arrow season and black
21 powder season the purchaser must also purchase a bow and arrow or black powder stamp.

22 [(ii)] (III) 1. [A] THERE IS A nonresident hunting license that
23 enables the purchaser to hunt all legal game birds and mammals during any appropriate
24 season without the purchase of additional stamps unless the purchaser is hunting
25 migratory game birds or deer during bow and arrow season or black powder season.

26 2. This license enables the purchaser to hunt migratory
27 game birds only with the purchase of a Maryland migratory game bird stamp and to hunt
28 wild waterfowl only with the purchase of both a Maryland migratory game bird stamp and
29 a federal migratory bird hunting and conservation stamp.

30 3. This license enables the purchaser to hunt deer during
31 bow and arrow season and black powder season only with the purchase of a nonresident
32 bow and arrow or black powder stamp.

33 [(iii)] (IV) 1. [A] THERE IS A nonresident 3-day hunting license
34 that enables the purchaser to hunt all legal game birds and mammals except deer and
35 turkey for the 3 consecutive legal hunting days in a single season that are specified on the
36 license by the issuing agent.

1 2. The purchaser must also purchase a Maryland migratory
2 game bird stamp to hunt migratory game birds and a federal migratory bird hunting and
3 conservation stamp to hunt wild waterfowl with this license.

4 3. Under no circumstance does this license authorize the
5 purchaser to hunt deer and turkey.

6 [(iv)] (v) 1. A. [An] **THERE IS AN** apprentice hunting
7 license that enables the purchaser to hunt all legal game birds and mammals in a single
8 season without the purchase of additional stamps unless the purchaser is hunting
9 migratory game birds or deer during bow and arrow season or black powder season.

10 B. This license enables the purchaser to hunt migratory
11 game birds only with the purchase of a Maryland migratory game bird stamp and to hunt
12 wild waterfowl only with the purchase of both a Maryland migratory game bird stamp and
13 a federal migratory bird hunting and conservation stamp.

14 C. This license enables the purchaser to hunt deer during
15 bow and arrow season and black powder season only with the purchase of a bow and arrow
16 or black powder stamp.

17 2. A. A person may obtain an apprentice hunting license
18 on satisfactory completion of a short online or electronic course of instruction in competency
19 in firearms and hunter safety approved by the Department.

20 B. A person may hunt under an apprentice hunting license
21 only if accompanied and directly supervised by another person who is at least 18 years of
22 age and possesses a valid resident nonapprentice hunting license issued under this subtitle.

23 C. A person who accompanies and directly supervises an
24 apprentice hunting licensee shall maintain close visual and verbal contact with, provide
25 adequate direction to, and be in a position to immediately assume control of the firearm of
26 the apprentice hunting licensee.

27 3. Except for a person participating in a junior hunt
28 approved by the Department, an apprentice hunting licensee who has obtained a certificate
29 of competency in firearms and hunter safety under § 10–301.1 of this subtitle may hunt
30 without supervision.

31 4. [An] **EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH 5**
32 **OF THIS SUBPARAGRAPH, AN** apprentice hunting license:

33 A. May be issued to a person only once in the person's
34 lifetime;

B. May not be renewed; and

C. May not be issued to a person who has previously been issued any hunting license under this subtitle.

5. A. NOTWITHSTANDING SUBSUBPARAGRAPH 4 OF THIS SUBPARAGRAPH, THE DEPARTMENT MAY ISSUE AN APPRENTICE HUNTING LICENSE TO A PERSON UNDER THE AGE OF 17 YEARS WHO HAS PREVIOUSLY BEEN ISSUED AN APPRENTICE HUNTING LICENSE.

B. THE DEPARTMENT SHALL REQUIRE AN APPLICANT FOR A SECOND OR SUBSEQUENT APPRENTICE HUNTING LICENSE UNDER THIS SUBSUBPARAGRAPH TO REPEAT THE COURSE OF INSTRUCTION IN COMPETENCY IN FIREARMS AND HUNTER SAFETY SPECIFIED UNDER SUBSUBPARAGRAPH 2A OF THIS SUBPARAGRAPH.

(2) Residents may purchase a senior hunting license beginning in the calendar year in which they attain the age of 65.

(3) A nonresident of any age must purchase either a nonresident hunting license or a nonresident 3-day hunting license to hunt in the State.

(4) Subject to paragraph (6) of this subsection, the fees for hunting licenses are according to the following schedule:

(i)	Resident, junior, under the age of 16 years	\$ 10.50
(ii)	Resident, regular, at least 16 years old and under the age of 65 years.....	\$ 24.50
(iii)	Resident, senior, at least 65 years old.....	\$ 5.00
(iv)	Nonresident, regular, at least 16 years old.....	\$ 130.00
(v)	Nonresident, junior, under the age of 16 years.....	\$ 65.00
(vi)	Complimentary license authorized to be issued under § 10-303 of this subtitle.....	No fee
(vii)	Nonresident 3-day hunting license.....	\$ 45.00
(viii)	Resident apprentice.....	\$ 10.00
(ix)	Nonresident apprentice.....	\$ 20.00

1 (5) The fees for individual hunting stamps are according to the following
2 schedule:

- 3 (i) Bow and arrow stamp \$ 6.00
- 4 (ii) Nonresident bow and arrow stamp \$ 25.00
- 5 (iii) Black powder stamp..... \$ 6.00
- 6 (iv) Nonresident black powder stamp \$ 25.00
- 7 (v) Maryland migratory game bird stamp \$ 9.00
- 8 (vi) Resident bonus antlered deer stamp..... \$ 10.00
- 9 (vii) Nonresident bonus antlered deer stamp for each type of deer
10 hunting season..... \$ 25

11 (6) The Department shall establish a program to provide discounted
12 hunting licenses and any associated State-issued stamps or permits to Maryland residents
13 who are recipients of the Purple Heart Award.

14 (i) A hunting license shall be valid for the period August 1 through July 31, of
15 each year.

16 (j) A hunting license may not be transferred to any other person.

17 (k) Upon issuing any hunting license, the Department shall furnish the licensee
18 with a list of the names and addresses of every general hospital in the State which offers
19 emergency medical treatment.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
21 1, 2023.
