4 FOR the purpose of ~~requiring~~ establishing that a county or a municipal corporation has the
5 authority to ~~process~~ approve or deny any local permit required under a certificate of
6 public convenience and necessity issued by the Public Service Commission for
7 generating stations, transmission lines, and qualified generator lead lines; requiring
8 a county or municipal corporation to ~~process~~ approve or deny the local permits in a
9 certain manner; prohibiting a county or municipal corporation from conditioning the
10 approval of the local permits on certain ~~reviews, approvals, and findings~~ approvals;
11 and generally relating to certificates of public convenience and necessity.

AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that nothing in this Act shall be interpreted to abrogate, modify, or limit the holding of the Supreme Court of Maryland in Board of County Commissioners of Washington County, Maryland v. Perennial Solar, LLC, 464 Md. 610 (2019).

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023.
