 $\mathbf{5}$ FOR the purpose of authorizing the Maryland Community Health Resources Commission, 6 in consultation with the Secretary of Health, to set the compensation of certain 7 Commission employees; requiring the Secretary of Budget and Management, in 8 consultation with the Secretary of Health, to determine the positions for which the 9 Commission may set compensation; authorizing the Comptroller, the Treasurer, and 10 the Attorney General, in consultation with the Secretary of Budget and 11 Management, to set the pay scale of certain positions in their offices; and generally relating to the Maryland Community Health Resources Commission and employee 12 13compensation and pay scales.
