## Consumer Protection - Right to Repair - Farm Equipment

3 FOR the purpose of requiring an original equipment manufacturer to make available 4 certain documentation, updates, or information to an independent repair provider or 5 owner of farm equipment to allow for the diagnosis, maintenance, or repair of the 6 farm equipment; providing that any contractual agreement purporting to waive, 7 avoid, or limit a farm equipment manufacturer's compliance with this Act is void; 8 prohibiting a farm equipment manufacturer from knowingly misrepresenting or 9 withholding farm equipment part numbers from a customer for a certain purpose; 10 and generally relating to the right to repair farm equipment.

- 6 (1) AN UNFAIR, ABUSIVE, OR DECEPTIVE TRADE PRACTICE WITHIN 7 THE MEANING OF TITLE 13 OF THIS ARTICLE; AND
- 8 (2) SUBJECT TO THE ENFORCEMENT AND PENALTY PROVISIONS 9 CONTAINED IN TITLE 13 OF THIS ARTICLE.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to apply only prospectively and may not be applied or interpreted to abrogate, interfere with, contradict, or alter the terms of any contract that is executed between an authorized repair provider and a farm equipment manufacturer before the effective date of this Act.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2023.
