## A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County – Sheriff – Salary**

3 FOR the purpose of altering the annual salary of the Sheriff of Frederick County to be equal  
4 to the salary of a Department of State Police lieutenant colonel, at the highest  
5 available step for a lieutenant colonel under the Department of State Police pay plan;  
6 and generally relating to the salary of the Sheriff of Frederick County.

7 BY repealing and reenacting, without amendments,

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

19 **Article – Courts and Judicial Proceedings**

20 2–324.

21 (a) This section applies only in Frederick County.

22 (b) **(1)** The **SALARY FOR THE** Sheriff of Frederick County [shall receive an  
23 annual salary of \$125,000] **IS EQUAL TO THE SALARY OF A DEPARTMENT OF STATE**

1 POLICE LIEUTENANT COLONEL, AT THE HIGHEST AVAILABLE STEP FOR A  
2 LIEUTENANT COLONEL UNDER THE DEPARTMENT OF STATE POLICE PAY PLAN IN  
3 EFFECT ON THE DAY PRIOR TO THE DAY THAT THE SHERIFF BEGINS A TERM OF  
4 OFFICE.

5 (2) ANY CHANGE IN THE SALARY PAID UNDER THE DEPARTMENT OF  
6 STATE POLICE PAY PLAN DURING THE TERM OF OFFICE OF THE SHERIFF MAY NOT  
7 APPLY TO THE INCUMBENT SHERIFF, BUT THE CHANGED RATE SHALL TAKE EFFECT  
8 AT THE BEGINNING OF THE NEXT FOLLOWING TERM OF OFFICE.

9 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 35  
10 of the Maryland Constitution, this Act may not be construed to extend or apply to the salary  
11 or compensation of the Sheriff of Frederick County while serving in a term of office  
12 beginning before the effective date of this Act, but the provisions of this Act concerning the  
13 salary or compensation of the Sheriff of Frederick County shall take effect at the beginning  
14 of the next following term of office. This limitation does not apply to an individual appointed  
15 or elected after the effective date of this Act to fill out an unexpired term.

16 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
17 October 1, 2023.
