A BILL ENTITLED

1 AN ACT concerning

2 **Education – Accountability and Implementation Board – Membership**

3 FOR the purpose of altering the membership and qualifications of members of the
4 Accountability and Implementation Board; requiring the Accountability and
5 Implementation Board Nominating Committee to submit a certain slate of nominees
6 to the Governor on or before a certain date; and generally relating to the membership
7 of the Accountability and Implementation Board.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Education**

21 5–402.

22 (a) Beginning on July 1, 2020, and continuing until June 30, 2032, there is an
23 Accountability and Implementation Board.

1 (d) (1) (i) 1. The Board is composed of [seven] 11 members appointed
2 by the Governor, with the advice and consent of the Senate, chosen from a slate prepared
3 by the Nominating Committee established under § 5–403 of this subtitle.

4 2. **OF THE 11 MEMBERS OF THE BOARD:**

5 A. **ONE MEMBER SHALL BE A RESIDENT OF WESTERN**
6 **MARYLAND, WHICH IS THE REGION THAT CONSISTS OF ALLEGANY, CARROLL,**
7 **FREDERICK, GARRETT, AND WASHINGTON COUNTIES;**

8 B. **ONE MEMBER SHALL BE A RESIDENT OF SOUTHERN**
9 **MARYLAND, WHICH IS THE REGION THAT CONSISTS OF CALVERT, CHARLES, AND ST.**
10 **MARY’S COUNTIES;**

11 C. **ONE MEMBER SHALL BE A RESIDENT OF THE**
12 **EASTERN SHORE, WHICH IS THE REGION THAT CONSISTS OF CAROLINE, CECIL,**
13 **DORCHESTER, KENT, QUEEN ANNE’S, SOMERSET, TALBOT, WICOMICO, AND**
14 **WORCESTER COUNTIES; AND**

15 D. **THERE SHALL BE ONE MEMBER FROM EACH OF THE**
16 **FIVE COUNTIES WITH THE LARGEST STUDENT POPULATIONS IN THE STATE.**

17 (ii) When appointing members of the Board, the Governor shall
18 select from the slate of nominees nominated in accordance with § 5–403(c) of this subtitle.

19 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before August 1, 2023,
20 the Accountability and Implementation Board Nominating Committee shall, in accordance
21 with § 5–403 of the Education Article, submit a slate of nominees to the Governor for the
22 initial appointment of the following four members added to the Accountability and
23 Implementation Board as enacted under Section 1 of this Act:

24 (1) one member who is a resident of Western Maryland;

25 (2) one member who is a resident of Southern Maryland;

26 (3) one member who is a resident of the Eastern Shore; and

27 (4) one member who is a resident of Prince George’s County.

28 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
29 1, 2023.
