  assault evidence collection kits; requiring a law enforcement agency and a person
  with control or possession of a sexual assault evidence collection kit to report certain
  information to the program and comply with certain regulations; clarifying the uses
  for the Rape Kit Testing Grant Fund; and generally relating to a sexual assault

#### Article – Public Safety

10 4-401.

11 (a) (1) In this section the following words have the meanings indicated.

12 (2) "Forensic laboratory" means a facility, an entity, or a site that offers or 13 performs forensic analysis and is owned or operated by the State, a county or municipal 14 corporation in the State, or another governmental entity.

(3) "Fund" means the Rape Kit Testing Grant Fund.

(4) "Law enforcement agency" means the Department of State Police or a
 police department of a county or municipal corporation in the State.

18 (b) There is a Rape Kit Testing Grant Fund.

19 (c) The purpose of the Fund is to provide law enforcement agencies with funding 20 to pay for testing of sexual assault evidence collection kits by forensic laboratories.

21 (d) The Executive Director of the Governor's Office of Crime Prevention, Youth, 22 and Victim Services shall:

23 (1) administer the Fund;

24 (2) establish and publish procedures for the distribution of funding to law 25 enforcement agencies;

26 (3) ensure each jurisdiction in the State that has a forensic laboratory is 27 able to access the Fund;

(4) consider the number of sexual assault incidents that were investigated
by a law enforcement agency in the prior fiscal year when distributing funding; and

1 (5) submit a report with information on the distribution of funding to the 2 General Assembly, in accordance with § 2–1257 of the State Government Article, before 3 September 1 each year.

4 (e) (1) The Fund is a special, nonlapsing fund that is not subject to § 7–302 of 5 the State Finance and Procurement Article.

6 (2) The State Treasurer shall hold the Fund separately, and the 7 Comptroller shall account for the Fund.

- 8 (f) The Fund consists of:
- 9 (1) money appropriated in the State budget to the Fund;
- 10 (2) any interest earnings of the Fund; and

11(3) any other money from any other source accepted for the benefit of the12Fund.

13 (g) (1) The Fund may be used only for equipment, supplies, personnel, and 14 outsourcing necessary for the testing of sexual assault evidence collection kits in forensic 15 laboratories.

## 16 (2) SUBJECT TO PARAGRAPH (1) OF THIS SUBSECTION, THE FUND 17 MAY BE USED FOR EQUIPMENT, SUPPLIES, PERSONNEL, AND OUTSOURCING 18 NECESSARY FOR THE TESTING OF SEXUAL ASSAULT EVIDENCE COLLECTION KITS 19 COLLECTED BEFORE OR AFTER THE ESTABLISHMENT OF THE FUND.

20 (h) (1) The State Treasurer shall invest the money of the Fund in the same 21 manner as other State money may be invested.

(2) Any interest earnings of the Fund, including interest earnings undersubsection (f) of this section, shall be credited to the Fund.

24 (i) Expenditures from the Fund may be made only in accordance with the State 25 budget.

(j) Money expended from the Fund for testing of sexual assault evidence
 collection kits is supplemental to and is not intended to take the place of funding that
 otherwise would be appropriated for testing of sexual assault evidence collection kits.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 30 October 1, 2023.
