AN ACT concerning

State Procurement - Minority Business Enterprise Program - Extension and Reports

FOR the purpose of altering the termination date for certain provisions of law governing the Minority Business Enterprise Program and its application to offshore wind projects and video lottery terminals; altering the date by which certain reports, studies, and guidelines must be submitted; and generally relating to the Minority Business Enterprise Program.

In preparation for the study, the Board of Public Works may adopt regulations authorizing a unit of State government to require bidders and offerors to submit information necessary for the conduct of the study. The Board of

- Public Works may designate that certain information received in accordance with 1 2 regulations adopted under this section shall be confidential. Notwithstanding that certain 3 information may be designated by the Board of Public Works as confidential, the
- 4 Certification Agency may provide the information to any person that is under contract with
- 5 the Certification Agency to assist in conducting the study. The study shall also evaluate
- 6 race—neutral programs and other methods that can be used to address the needs of minority
- 7 businesses. The final report on the study shall be submitted to the Legislative Policy
- 8 Committee of the General Assembly, in accordance with § 2–1257 of the State Government
- 9 Article, ON OR before [September] DECEMBER 30, 2023 2024, so that the General
- 10 Assembly may review the report before the 2024 **2025** Session.

Chapter 641 of the Acts of 2022

SECTION 2. AND BE IT FURTHER ENACTED, That:

- 13 The certification agency and the Governor's Office of Small, Minority, and Women Business Affairs shall submit the findings of the study required under subsection 14 (a) of this section to the Legislative Policy Committee, in accordance with § 2–1257 of the State Government Article, on or before [July 1, 2023] **DECEMBER 30** 31, 2023 2025, so that the General Assembly may review the findings before the 2024 2026 Session. 17
 - The Governor's Office of Small, Minority, and Women Business Affairs, in (d) consultation with the certification agency and the Office of the Attorney General, shall develop race— and gender-neutral approaches to address the needs of minority and women-owned businesses in the brokerage and investment management services industry and market and submit its report to the Legislative Policy Committee, in accordance with § 2-1257 of the State Government Article, on or before December [1, 2022] 30 31, 2023 2025, so that the General Assembly may review, consider, and adopt race- and gender-neutral alternatives to remedial measures that are not race and gender neutral.
