 vehicle sensors producing recorded images of motor vehicles traveling at speeds at least 12
 miles per hour above the posted speed limit.~~

~~(b) (1) (i) 1. [A] EXCEPT AS PROVIDED IN SUBSUBPARAGRAPH 2
 OF THIS SUBPARAGRAPH, A speed monitoring system may not be used in a local
 jurisdiction under this section unless its use is authorized by the governing body of the local
 jurisdiction by local law enacted after reasonable notice and a public hearing.~~

~~2. A. SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH DOES NOT APPLY TO A SPEED MONITORING SYSTEM PLACED AND USED ON MARYLAND ROUTE 200 (INTERCOUNTY CONNECTOR) IN MONTGOMERY COUNTY.~~

THE MARYLAND TRANSPORTATION AUTHORITY AND MONTGOMERY COUNTY SHALL ENTER INTO A MEMORANDUM OF UNDERSTANDING REQUIRING MONTGOMERY COUNTY TO IMPLEMENT AND ADMINISTER THE SPEED MONITORING SYSTEMS PLACED AND USED ON MARYLAND ROUTE 200 (INTERCOUNTY CONNECTOR) UNDER SUBPARAGRAPH (VII)3 OF THIS PARAGRAPH.~~

~~(ii) Before a county may use a speed monitoring system on a State highway at a location within a municipal corporation IN ACCORDANCE WITH SUBPARAGRAPH (VI)1 THROUGH 5 OF THIS PARAGRAPH, the county shall:~~

~~1. Obtain the approval of the State Highway Administration;~~

~~2. Notify the municipal corporation of the State Highway Administration's approval of the use of a speed monitoring system at that location; and~~

~~3. Grant the municipal corporation 60 days from the date of the county's notice to the municipal corporation to enact an ordinance authorizing the municipal corporation instead of the county to use a speed monitoring system at that location.~~

~~(vi) This section applies to a violation of this subtitle recorded by a speed monitoring system that meets the requirements of this subsection and has been placed:~~

~~1. In Montgomery County or Prince George's County, on a highway in a residential district, as defined in § 21-101 of this title, with a maximum posted speed limit of 35 miles per hour, which speed limit was established using generally accepted traffic engineering practices;~~

~~2. In a school zone with a posted speed limit of at least 20 miles per hour;~~

~~3. In Prince George's County;~~

~~A. Subject to subparagraph (vii)1 of this paragraph, on Maryland Route 210 (Indian Head Highway); or~~

~~B. On that part of a highway located within the grounds of an institution of higher education as defined in § 10-101(h) of the Education Article, or within one-half mile of the grounds of a building or property used by the institution of higher education where generally accepted traffic and engineering practices indicate that~~

~~motor vehicle, pedestrian, or bicycle traffic is substantially generated or influenced by the institution of higher education;~~

~~4. Subject to subparagraph (vii)² of this paragraph, on Interstate 83 in Baltimore City; **[or]**~~

~~5. In Anne Arundel County, on Maryland Route 175 (Jessup Road) between the Maryland Route 175/295 interchange and the Anne Arundel County-Howard County line; **OR**~~

~~**6. SUBJECT TO SUBPARAGRAPH (VII)³ OF THIS PARAGRAPH, ON MARYLAND ROUTE 200 (INTERCOUNTY CONNECTOR) IN MONTGOMERY COUNTY BETWEEN THE SHADY GROVE ROAD EXIT RAMPS AND THE ROUTE 29 EXIT RAMPS.**~~

~~(vii) 1. Not more than three speed monitoring systems may be placed on Maryland Route 210 (Indian Head Highway).~~

~~2. Not more than two speed monitoring systems may be placed on Interstate 83 in Baltimore City.~~

~~**3. A. FOUR MOBILE SPEED MONITORING SYSTEMS SHALL BE PLACED AND USED ON MARYLAND ROUTE 200 (INTERCOUNTY CONNECTOR) IN MONTGOMERY COUNTY.**~~

~~**B. NOT MORE THAN TWO MOBILE SPEED MONITORING SYSTEMS MAY BE OPERATIONAL ON MARYLAND ROUTE 200 (INTERCOUNTY CONNECTOR) AT ANY TIME.**~~

~~(e) (1) Unless the driver of the motor vehicle received a citation from a police officer at the time of the violation, the owner or, in accordance with subsection (f)(4) of this section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is recorded by a speed monitoring system while being operated in violation of this subtitle.~~

~~(2) A civil penalty under this subsection may not exceed \$40.~~

~~(3) For purposes of this section, the District Court shall prescribe:~~

~~(i) A uniform citation form consistent with subsection (d)(1) of this section and § 7-302 of the Courts Article; and~~

~~(ii) A civil penalty, which shall be indicated on the citation, to be paid by persons who choose to prepay the civil penalty without appearing in District Court.~~

~~**SECTION 2. AND BE IT FURTHER ENACTED,** That this Act shall take effect July 1, 2023.~~

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND.

2 That:

3 (a) The Maryland Transportation Authority shall:

4 (1) place four devices along each roadway on Maryland Route 200
5 (Intercounty Connector) in Montgomery County that display a real-time posting of the
6 speed at which a driver is traveling;

7 (2) increase speed enforcement efforts on Maryland Route 200 (Intercounty
8 Connector) in Montgomery County; and

9 (3) collect data on citations issued for speed violations on Maryland Route
10 200 (Intercounty Connector) in Montgomery County.

11 (b) On or before December 31, 2024, the Maryland Transportation Authority shall
12 report to the Montgomery County Delegation to the General Assembly, in accordance with
13 § 2-1257 of the State Government Article, on enforcement efforts and data collected by the
14 Authority under subsection (a) of this section.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
16 October 1, 2023. It shall remain effective for a period of 1 year and 9 months and, at the
17 end of June 30, 2025, this Act, with no further action required by the General Assembly,
18 shall be abrogated and of no further force and effect.
