A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicle Registration – Exception for Golf Carts – Town of Charlestown**

3 FOR the purpose of creating an exception to motor vehicle registration requirements for
4 golf carts in the Town of Charlestown, Cecil County, subject to certain requirements
5 and conditions; authorizing the Town Commissioners of the Town of Charlestown to
6 designate highways on which a person may operate a golf cart in the Town of
7 Charlestown; and generally relating to exceptions to motor vehicle registration
8 requirements for golf carts.

24 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
25 That the Laws of Maryland read as follows:

26 **Article – Transportation**

2 (a) (1) Except as otherwise provided in this section or elsewhere in the
3 Maryland Vehicle Law, each motor vehicle, trailer, semitrailer, and pole trailer driven on
4 a highway shall be registered under this subtitle.

5 (c) Registration under this subtitle is not required for:

6 (12) A golf cart that is operated on a highway in accordance with § 21-104.2,
7 § 21-104.3, § 21-104.4, [or] § 21-104.6, **OR § 21-104.7** of this article;

8 **21-104.7.**

9 (A) **SUBJECT TO SUBSECTION (B) OF THIS SECTION, A PERSON WHO**
10 **OPERATES A GOLF CART ON A HIGHWAY IN THE TOWN OF CHARLESTOWN, CECIL**
11 **COUNTY, WITHOUT REGISTRATION AS AUTHORIZED UNDER § 13-402(C)(12) OF THIS**
12 **ARTICLE:**

13 (1) **MAY OPERATE THE GOLF CART ONLY:**

14 (I) **ON A HIGHWAY ON WHICH THE MAXIMUM POSTED SPEED**
15 **LIMIT DOES NOT EXCEED 30 MILES PER HOUR; AND**

16 (II) **IF THE GOLF CART IS EQUIPPED WITH LIGHTING DEVICES**
17 **AS REQUIRED BY THE ADMINISTRATION;**

18 (2) **SHALL KEEP THE GOLF CART AS FAR TO THE RIGHT OF THE**
19 **ROADWAY AS FEASIBLE; AND**

20 (3) **SHALL POSSESS A VALID DRIVER'S LICENSE.**

21 (B) **THE TOWN COMMISSIONERS OF THE TOWN OF CHARLESTOWN MAY**
22 **DESIGNATE BY RESOLUTION THE HIGHWAYS IN THE TOWN OF CHARLESTOWN,**
23 **CECIL COUNTY, ON WHICH A PERSON MAY OPERATE A GOLF CART.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
25 October 1, 2023.
